AN ACT to authorize the town of Brookhaven, county of Suffolk, to alienate and discontinue the use of certain parklands

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subject to the provisions of this act, the town of Brookha-2 ven, county of Suffolk, acting by and through its governing body, and upon such terms and conditions as determined by such body, is hereby authorized to discontinue as parkland the lands more particularly described in section three of this act and convey such lands to New York Site Operations, LLC for the purpose of improving rail access.

- § 2. The authorization provided in section one of this act shall be effective only upon the condition that the town of Brookhaven, county of Suffolk, dedicate the lands more particularly described in section four 10 of this act for parkland purposes, provided that the town of Brookhaven 11 has never used such lands for public open space or park purposes.
- § 3. The parklands authorized by section one of this act to be alien-13 ated are described as follows:
- Beginning at the northeast corner of the herein described property, 15 said point being more particularly described thus:
- Commencing at the intersection of the easterly line of Old Town Road 16 with the northerly line of Horse Block Road (Suffolk County Route 16), 17
- said point being the southwest corner of property acquired by the County 18
- 19 of Suffolk from Decca Navigator Systems, Inc. per Map No. 93 entitled
- 20 "Map Showing Property to be Acquired from Decca Navigator System, Inc.
- 21 for County Purposes" County of Suffolk Department of Public Works R.M.

In the event that the fair market value of the lands described in section four of this act to be dedicated by the town of Brookhaven pursuant to this act are not equal to or greater than the fair market value of the parklands to be alienated as described in section three of this act, the town of Brookhaven, shall dedicate the difference of fair market value of the lands to be alienated and the lands to be dedicated for the acquisition of additional parklands and/or capital improvements to existing park and recreational facilities.
- 37 § 6. In the event that the town of Brookhaven received any funding 38 support or assistance from the federal government for the purchase, maintenance or improvement of the parklands set forth in section three 39 this act, the discontinuance and alienation of such parkland author-40 ized by the provisions of this act shall not occur until the town of 41 Brookhaven has complied with any federal requirements pertaining to the alienation or conversion of parklands, including satisfying the secre-44 tary of the interior that the alienation or conversion complies with all 45 conditions which the secretary of the interior deems necessary to assure 46 the substitution of other lands shall be equivalent in fair market value 47 and usefulness to the lands being alienated or converted.
- 48 § 7. This act shall take effect immediately.
