AN ACT to amend the real property tax law, in relation to conservation easement agreement exemptions in certain towns

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

## Section 1. The real property tax law is amended by adding a new 1 2 section 491-b to read as follows: 3 <u>§ 491-b. Conservation easement agreement exemption; certain towns. 1.</u> 4 Applicability. In a town having a population of not less than thirty-5 five thousand and not more than thirty-six thousand, that is located in a county having a population of not less than three hundred thousand and 6 7 not more than three hundred seven thousand, based upon and recorded by 8 the two thousand ten federal census, is hereby authorized to adopt a 9 local law to provide that, real property whose interests or rights have 10 been acquired for the purpose of the preservation of an open space or an open area, as authorized in section two hundred forty-seven of the 11 general municipal law, may be partially exempt from local real property 12 taxation, provided that the owner or owners of such real property enter 13 14 into a conservation easement agreement with the municipality in accord-15 ance with the procedures specified in subdivision three of this section. 16 A county having a population of not less than three hundred thousand and not more than three hundred seven thousand based upon and recorded in 17 the two thousand ten federal census may, by local law, and any school 18 district, all or part of which is located in a town having a population 19 20 of not less than thirty-five thousand and not more than thirty-six thou-21 sand that is located in a county having a population of not less than 22 three hundred thousand and not more than three hundred seven thousand based upon and recorded by the two thousand ten federal census, may, by 23 24 resolution, exempt such property from its taxation in the same manner 25 and to the same extent as such town has done.

1 Definitions. For the purpose of this section, the following terms 2. shall have the following meanings: "open space" or "open area" means any 2 3 space or area characterized by natural scenic beauty or whose existing 4 openness, natural condition or present state of use, if retained, would 5 enhance the present or potential value of abutting or surrounding urban б development or would maintain or enhance the conservation of natural or 7 scenic resources. For the purposes of this definition, "natural or 8 scenic resources" shall include, but not be limited to, agricultural 9 lands defined as open lands actually used in bona fide agricultural 10 production. 3. Procedures for obtaining a conservation easement agreement. (a) Any 11 owner or owners of land may submit a proposal to the town board of a 12 13 town having a population of not less than thirty-five thousand and not more than thirty-six thousand that is located in a county having a popu-14 15 lation of not less than three hundred thousand and not more than three 16 hundred seven thousand, based upon and recorded by the two thousand ten federal census, for the granting of interest or rights in real property 17 for the preservation of open space or areas. Such proposal shall be 18 19 submitted in such a manner and form as may be prescribed by the conser-20 vation board of such town. 21 (b) Upon receipt of such proposal, the town board shall convey the proposal to the conservation board of such town. Such conservation board 22 shall investigate the area to determine if the proposal would be of 23 24 benefit to the people of the town and may negotiate the terms and conditions of the offer. If the conservation board determines that it is in 25 26 the public interest to accept such proposal, it shall recommend to the 27 town board that it hold a public hearing for the purpose of determining whether or not the town should accept such proposal. 28 29 (c) The town board shall, within thirty days of receipt of such advi-30 sory opinion, hold a public hearing concerning such proposal at a place 31 within the town. At least ten days notice of the time and place of such 32 hearing shall be published in a paper of general circulation in such 33 town, and a written notice of such proposal shall be given to all adja-34 cent property owners and to any municipality whose boundaries are within 35 five hundred feet of the boundaries of said proposed area, and to the school district in which it is located. 36 37 (d) The town board, after receiving the reports of the conservation 38 board of a town having a population of not less than thirty-five thousand and not more than thirty-six thousand that is located in a county 39 having a population of not less than three hundred thousand and not more 40 41 than three hundred seven thousand, based upon and recorded by the two 42 thousand ten federal census, and after such public hearing, may adopt 43 the proposal or any modification thereof it deems appropriate or may 44 reject it in its entirety. 45 (e) If such proposal is adopted by the town board, it shall be 46 executed by the owner or owners in written form and in a form suitable 47 for recording in the county clerk's office. 48 (f) Such agreement may not be canceled by either party. However, the owner or owners thereof may petition the town board for cancellation 49 50 upon good cause shown, and such cancellation may be granted only upon 51 payment of the penalties provided in this section. 4. Computation. (a) An exemption granted pursuant to this section 52 53 shall commence as of the effective date of the conservation easement 54 agreement, and shall terminate upon the expiration or termination of 55 such conservation easement agreement.

| 20 | (d) Whenever a conservation easement encumbers only a portion of a       |
| 21 | parcel, the assessor shall henceforth enter that portion of the parcel   |
| 22 | encumbered by such easement as a separate parcel on all subsequent       |
| 23 | assessment rolls.  |
| 24 | 5. Penalties for offenses. If there is a violation of the terms and      |
| 25 | conditions of the conservation easement agreement or if such conserva-   |
| 26 | tion easement agreement is canceled by the town board upon petition,     |
| 27 | then the owner or owners of such property must pay to the town the       |
| 28 | following amounts:   |
| 29 | (a) All taxes abated pursuant to the conservation easement agreement,    |
| 30 | as limited by the remainder of this section, including, if applicable,   |
| 31 | those taxes imposed by the county, town, school districts and all        |
| 32 | special improvement districts and other taxing units to which the prop-  |
| 33 | erty is subject. Repayment of the aforementioned abated taxes shall be   |
| 34 | equal to five times the taxes saved in the last year in which the land   |
| 35 | benefited from a conservation easement agreement exemption, plus inter-  |
| 36 | est of six percent per year compounded annually for each year in which   |
| 37 | an exemption was granted, not exceeding five years.                      |
| 38 | (b) Payments shall be added by or on behalf of each taxing jurisdic-     |
| 39 | tion to the taxes levied on the assessment roll prepared on the basis of |
| 40 | the first taxable status date after there is a violation of the terms    |
| 41 | and conditions of the conservation easement or such conservation ease-   |
| 42 | ment agreement is canceled.  |
