AN ACT to amend the alcoholic beverage control law, in relation to a license to sell liquor at retail for consumption on certain premises

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 7 of section 64 of the alcoholic beverage 2 control law is amended by adding a new paragraph (e-14) to read as 3 follows:

(e-14) Notwithstanding the provisions of paragraph (a) of this subdivision, the authority may issue a retail license for on-premises consumption for a premises which shall be located within two hundred feet of a building occupied as a church, synagogue or other place of 8 worship, provided such premises constitute a premises for the sale of food or beverages at retail for consumption on the premises located 10 wholly within the boundaries of the city of Beacon, county of Dutchess, 11 bounded and described as follows:
