AN ACT to amend the banking law, in relation to check cashing policies

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The banking law is amended by adding a new section 9-z to 2 read as follows:

§ 9-z. Cashing of certain checks. 1. No bank, trust company, savings bank, savings and loan association or credit union shall, refuse to cash 5 a cashier's check, a payroll check, or a certified check in the amount of five hundred dollars or less, drawn on accounts in such institution or a branch as long as there are sufficient funds within the account on 8 which the check is drawn. Such institution may require, as a condition for cashing such check, that the payee present a valid government-issued 10 photo identification and matching proof of address such as a bank state-11 ment, utility bill or printed pay stub.

2. If a person presents such forms of identification, as provided in 13 subdivision one of this section, and a signature or mark, and the insti-14 tution refuses to cash the check in the absence of suspected fraudulent 15 activity, such institution shall be quilty of a violation of this 16 section and shall be subject to penalties pursuant to section forty-four 17 of this chapter.

18 § 2. This act shall take effect on the ninetieth day after it shall 19 have become a law.
