AN ACT to amend the civil service law, in relation to veterans' credits for civil service appointments and promotions

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 1 of section 85 of the civil service law, as 2 added by chapter 790 of the laws of 1958, paragraph (a) and subparagraph 3 2 of paragraph (b) as amended by chapter 490 of the laws of 2019, para-4 graph (b) as amended by chapter 661 of the laws of 1983, subparagraph 3 5 of paragraph (b) and paragraph (c) as amended by chapter 467 of the laws 6 of 1991 and subparagraph 4 of paragraph (c) as amended by chapter 179 of 7 the laws of 2006, is amended to read as follows:

1. Definitions. (a) The terms "veteran" and "non-disabled veteran" 8 mean a member of the armed forces of the United States [who served ther-9 10 ein in time of war,] who was honorably discharged or released under 11 honorable circumstances from such service including (i) having a qualifying condition as defined in section three hundred fifty of the execu-12 tive law, and receiving a discharge other than bad conduct or dishonor-13 able from such service, or (ii) being a discharged LGBT veteran, as 14 defined in section three hundred fifty of the executive law, and receiv-15 ing a discharge other than bad conduct or dishonorable from such 16 service, who is a citizen of the United States or an alien lawfully 17 18 admitted for permanent residence in the United States and who is a resi-19 dent of the state of New York at the time of application for appointment 20 or promotion or at the time of retention, as the case may be.

(b) The term "disabled veteran" means a veteran who is certified by 22 the United States veterans' administration or a military department as 23 entitled to receive disability payments upon the certification of such

veterans' administration or a military department for a disability 1 incurred by him or her in [time of war] the course of his or her service 2 3 and in existence at the time of application for appointment or promotion 4 or at the time of retention, as the case may be. Such disability shall 5 be deemed to be in existence at the time of application for appointment б or promotion or at the time of retention, as the case may be, if the 7 certificate of such veterans' administration shall state affirmatively 8 that such veteran has been examined by a medical officer of such veter-9 ans' administration on a date within one year of either the date of 10 filing application for competitive examination for original appointment or promotion or the date of the establishment of the resulting eligible 11 list or within one year of the time of retention, as the case may be; 12 13 that at the time of such examination the [war-incurred] disability described in such certificate was found to exist; and that such disabil-14 15 ity is rated at ten per centum or more. Such disability shall also be 16 deemed to be in existence at such time if the certificate of such veter-17 ans' administration shall state affirmatively that a permanent stabi-18 lized condition of disability exists to an extent of ten per centum or 19 more, notwithstanding the fact that such veteran has not been examined 20 by a medical officer of such veterans' administration within one year of 21 either the time of application for appointment or promotion or the date 22 of filing application for competitive examination for original appointment or promotion, or within one year of the time of retention, as the 23 case may be. [The term "disabled veteran" shall also mean: 24 25 (1) A veteran who served in world war I, who continued to serve in the 26 armed forces of the United States after the eleventh day of November, 27 nineteen hundred eighteen, and who is certified, as hereinbefore provided, by the United States veterans' administration as receiving 28 disability payments upon the certification of such veterans' adminis-29 30 tration for a disability incurred by him in such service on or before 31 the second day of July, nineteen hundred twenty-one. 32 (2) A veteran who served in world war II, who continued to serve in 33 the armed forces of the United States after the second day of September, nineteen hundred forty-five, or who was employed by the War Shipping 34 35 Administration or Office of Defense Transportation or their agents as a merchant seaman documented by the United States Coast Guard or Depart-36 ment of Commerce, or as a civil servant employed by the United States 37 Army Transport Service (later redesignated as the United States Army 38 Transportation Corps, Water Division) or the Naval Transportation 39 Service; and who served satisfactorily as a crew member during the peri-40 od of armed conflict, December seventh, nineteen hundred forty-one, to 41 August fifteenth, nineteen hundred forty-five, aboard merchant vessels 42 43 in oceangoing, i.e., foreign, intercoastal, or coastwise service as such 44 terms are defined under federal law (46 USCA 10301 & 10501) and further 45 to include "near foreign" voyages between the United States and Canada, 46 Mexico, or the West Indies via ocean routes, or public vessels in oceangoing service or foreign waters and who has received a Certificate of 47 Release or Discharge from Active Duty and a discharge certificate, or an 48 Honorable Service Certificate/Report of Casualty, from the Department of 49

50 Defense, or who served as a United States civilian employed by the Amer-51 ican Field Service and served overseas under United States Armies and 52 United States Army Groups in world war II during the period of armed 53 conflict, December seventh, nineteen hundred forty-one through May 54 eighth, nineteen hundred forty-five, and who (i) was discharged or 55 released therefrom under honorable circumstances or (ii) has a qualify-

56 ing condition, as defined in section three hundred fifty of the execu-

8 9 tive law, and has received a discharge other than bad conduct or dishonorable from such service, or (iii) is a discharged LGBT veteran, as defined in section three hundred fifty of the executive law, and has received a discharge other than bad conduct or dishonorable from such service, or who served as a United States civilian Flight Crew and Aviation Ground Support Employee of Pan American World Airways or one of its subsidiaries or its affiliates and served overseas as a result of Pan American's contract with Air Transport Command or Naval Air Transport Service during the period of armed conflict, December fourteenth,

10 nineteen hundred forty-one through August fourteenth, nineteen hundred forty five, and who (iv) was discharged or released therefrom under 11 honorable circumstances or (v) has a qualifying condition, as defined in 12 13 section three hundred fifty of the executive law, and has received a discharge other than bad conduct or dishonorable from such service, or 14 (vi) is a discharged LCBT veteran, as defined in section three hundred 15 16 fifty of the executive law, and has received a discharge other than bad conduct or dishonorable from such service, and who is certified, as 17 hereinbefore provided, by the United States veterans' administration as 18 19 receiving disability payments upon the certification of such veterans' 20 administration for a disability incurred by him in such service on or before the date that world war II is declared terminated. 21

(3) A veteran who served during hostilities participated in by the 22 military forces of the United States subsequent to June twenty-seventh, 23 24 nineteen hundred fifty, and who continued to serve in the armed forces of the United States after the thirty first day of January, nineteen 25 hundred fifty-five, and who is certified, as hereinbefore provided, by 26 27 the United States veterans' administration as receiving disability payments upon the certification of such veterans ' administration for a 28 29 disability incurred by him in such service.

30 (c) The term "time of war" shall include the following wars and 31 hostilities for the periods and based upon the evidence herein set 32 forth:

33 (1) World war I, from the sixth day of April, nineteen hundred seven-34 teen, to and including the eleventh day of November, nineteen hundred 35 eighteen.

36 (2) World war II, from the seventh day of December, nineteen hundred
 37 forty-one, to and including the thirty-first day of December, nineteen
 38 hundred forty-six.

39 (3) Hostilities participated in by the military forces of the United 40 States, from the twenty-seventh day of June, nineteen hundred fifty, to 41 and including the thirty-first day of January, nineteen hundred fifty-42 five.

43 (4) Hostilities participated in by the military forces of the United
44 States, from the twenty-eighth day of February, nineteen hundred sixty45 one to the seventh day of May, nineteen hundred seventy-five.

46 (5) Hostilities participated in by the military forces of the United 47 States in Lebanon, from the first day of June, nineteen hundred eighty-48 three to the first day of December, nineteen hundred eighty-seven, as 40 stablished hundred in the first day of the first day

51 (6) Hostilities participated in by the military forces of the United 52 States in Grenada, from the twenty-third day of October, nineteen 53 hundred eighty-three to the twenty-first day of November, nineteen 54 hundred eighty-three, as established by receipt of the armed forces 55 expeditionary medal, the navy expeditionary medal, or the marine corps 56 expeditionary medal.

(7) Hostilities participated in by the military forces of the United
 States in Panama, from the twentieth day of December, nineteen hundred
 eighty-nine to the thirty-first day of January, nineteen hundred ninety,
 as established by receipt of the armed forces expeditionary medal, the
 navy expeditionary medal, or the marine corps expeditionary medal.

6 (8) Hostilities participated in by the military forces of the United
7 States in the Persian Gulf, from the second day of August, nineteen
8 hundred ninety to the end of such hostilities.

9 (d)] (c) The term "time of application for original appointment or 10 promotion" shall mean the date of the establishment of an eligible list 11 resulting from a competitive examination for original appointment or 12 promotion, as the case may be, which date shall be the date on which the 13 term of such eligible list commences.

14 [(e)] <u>(d)</u> The term "time of retention" shall mean the time of aboli-15 tion or elimination of positions.

16 § 2. This act shall take effect immediately, provided however, such 17 additional point shall only apply to competitive examinations for 18 original appointment and for promotion created after the effective date 19 of this act.
