AN ACT in relation to authorizing the county of Suffolk to transfer ownership of certain parkland to the town of Southold

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subject to the provisions of this act, the Suffolk county
2 legislature is hereby authorized and empowered to convey the property
3 described in section two of this act, which was heretofore used by such
4 county for park and/or recreational purposes, upon terms agreed upon
5 between the parties, to the town of Southold for use by such town for
6 park and/or recreational purposes, provided, however, that such town of
7 Southold shall continue to provide access to such parkland and/or recre-
8 ational facilities to all residents of the county of Suffolk and the
9 town shall not enact any fees or charges which are higher for county
10 residents who are not town residents. Any revenues received from the
11 county from the transfer shall be used for capital improvements of
12 existing park or recreational and/or the acquisition of additional park
13 or recreational facilities.

14 § 2. The lands referred to in section one of this act are located,
15 bounded and described as follows:

16 All that certain plot, piece or parcel of land, situate, lying and
17 being in the town of Southold, county of Suffolk, State of New York,
18 acquired by Suffolk county on May 5, 1993 as Suffolk county tax map No.
19 1000-122-4-44.8 and recorded in Liber 11630 at Page 6, otherwise known
20 as the underwater lands of James Creek more particularly bound and
21 described as follows:

22 BEGINNING at a point 200.00 feet North 37 degrees 24 minutes 20
23 seconds West from the Northwesterly side of Ole Jule Lane, where the
24 Northeasterly line of land now or formerly of Cooke
25 (SCTM 1000-122.-4-17) intersects the Northwesterly side of Ole Jule Lane
26 RUNNING THENCE THE FOLLOWING 219 COURSES AND DISTANCES:

53 § 3. Should the lands described in section two of this act cease to be
54 used for the purposes described in section one of this act, such lands
55 shall revert to the county of Suffolk for public park and recreational
56 purposes.

1 § 4. The land to be transferred pursuant to this act and all struc-
2 tures and facilities situated on such land shall be maintained, owned
3 and operated for park purposes by the town of Southold. The use of such
4 parkland and facilities shall continue to be made available to the
5 general public of the state of New York, including all residents of
6 Suffolk county and the town of Southold. Where the availability of such
7 facilities is limited, use of such facilities must be determined by an
8 equitable method.

9 § 5. In the event that the county of Suffolk received any funding
10 support or assistance from the federal government for the purchase,
11 maintenance or improvement of the parklands set forth in section two of
12 this act, the discontinuance and alienation of such parkland authorized
13 by the provisions of this act shall not occur until the county of
14 Suffolk has complied with any federal requirements pertaining to the
15 alienation or conversion of parklands, including satisfying the secre-
16 tary of the interior that the alienation or conversion complies with all
17 conditions which the secretary of the interior deems necessary to assure
18 the substitution of other lands shall be equivalent in fair market value
19 and usefulness to the lands being alienated or converted.

20 § 6. The Suffolk county executive, the state department of parks,
21 recreation and historic preservation, and the department of law are
22 hereby authorized, empowered and directed to effectuate the transfer of
23 real property consistent with the terms of this legislation.

24 § 7. This act shall take effect immediately.
