AN ACT to amend the social services law, in relation to the focus of the child care availability taskforce

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 3 of section 390-k of the social services law, as amended by a chapter of the laws of 2021 amending the social services law relating to representatives of the child care availability taskforce and the focus of such taskforce, as proposed in legislative bills numbers S. 7128 and A. 7721-A, is amended to read as follows:

- 3. The taskforce shall [examine the following with a focus on how each 7 component has been affected by the implementation of policies supported 8 by federally funded programs through various stimulus packages:
- 9 (a) affordable child care with a focus on the cost of care for fami-10 lies and factors that contribute to such costs;

- (b) access to and availability of subsidized child care, including the 11 12 identification of barriers families eligible under state law face 13 obtaining or utilizing such subsidies;
 - (c) availability of child care for non-traditional work hours;
- 15 (d) whether parents are voluntarily leaving the workforce due to lack 16 of affordable or accessible child care, and the demographic information of such parents, if known; 17
- (e) whether employers have identified lack of child care as a 19 for a shortage of a qualified workforce;
- 20 (f) the impact of child care, or lack thereof, on economic development throughout the state; 21
 - (g) varying levels of quality of care throughout the state;
- (h) availability of quality child care by economic development region 24 including identification of underserved communities;
- 25 (i) whether regulatory or statutory changes could promote access to 26 child care and improve health and safety standards in child care 27 programs;

- (a) examine the impact of the COVID-19 pandemic on child care in New York state;
- (b) advise the state in developing an implementation framework leading to a phased-in rollout of universal child care using existing state and federal resources;
- (c) recommend potential solutions, partnerships, or other ways to address chronic child care workforce issues and other concerns identified in the course of the examination required by this subdivision;
- $\left[\frac{1}{1}\right]$ (d) assess the implementation of policies supported by federally funded programs through various stimulus packages; and

 $[\frac{(m)}{(e)}]$ anything else the taskforce deems necessary.

§ 2. This act shall take effect on the same date and in the same manner as a chapter of the laws of 2021 amending the social services law relating to representatives of the child care availability taskforce and the focus of such taskforce, as proposed in legislative bills numbers S. 7128 and A. 7721-A, takes effect; provided, however, that the amendments to section 390-k of the social services law made by section one of this 20 21 act shall not affect the repeal of such section and shall be deemed 22 repealed therewith.
