AN ACT to amend the environmental conservation law, in relation to advanced recycling and advanced recycling facilities

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivisions 1 and 7 of section 27-0303 of the environ-2 mental conservation law, subdivision 1 as amended by chapter 671 of the 3 laws of 1986, and subdivision 7 as added by chapter 592 of the laws of 4 1981, are amended to read as follows:

1. "Disposal" means the abandonment, discharge, deposit, injection, 5 б dumping, spilling, leaking or placing of any substance so that such 7 substance or any related constituent thereof may enter the environment. Disposal also means the thermal destruction of waste or hazardous waste 8 and the burning of such wastes as fuel for the purpose of recovering 9 useable energy, but does include the conversion of post-use polymers and 10 11 recovered feedstocks at an advanced recycling facility as such terms are 12 defined pursuant to section 27-0701 of this article.

13 7. "Waste" means any garbage, refuse, sludge from a waste treatment 14 plant, water supply treatment plant or air pollution control facility, 15 and other discarded material, including solid, liquid, semisolid or 16 contained gaseous material resulting from industrial, commercial, mining 17 and agricultural operations and from community activities, but does not include solid or dissolved material in domestic sewage, or solid or 18 dissolved materials in irrigation return flows or industrial discharges 19 which are point sources subject to permits under article 17 of this 20 chapter, or source, special nuclear or by-product material as defined in 21 22 the Atomic Energy Act of 1954, as amended (68 Stat. 923) except as may 23 be provided by existing agreements between the state and the federal 24 government, or post-use polymers and recovered feedstocks converted at an advanced recycling facility as such terms are defined pursuant to 25 26 section 27-0701 of this article, or held at such facility prior to 27 <u>conversion</u>.

1 § 2. Subdivisions 1 and 2 of section 27-0701 of the environmental 2 conservation law, subdivision 1 as amended by chapter 425 of the laws of 3 1977 and subdivision 2 as amended by chapter 253 of the laws of 1988, 4 are amended and eight new subdivisions 5, 6, 7, 8, 9, 10, 11 and 12 are 5 added to read as follows:

6 1. "Solid waste" means all putrescible and non-putrescible materials 7 or substances discarded or rejected as being spent, useless, worthless in excess to the owners at the time of such discard or rejection, 8 or 9 except including but not limited to garbage, refuse, industrial and 10 commercial waste, sludges from air or water control facilities, rubbish, 11 ashes, contained gaseous material, incinerator residue, demolition and 12 construction debris, discarded automobiles and offal but not including sewage and other highly diluted water carried materials or substances 13 14 [and], those in gaseous form, and post-use polymers and recovered feeds-15 tocks converted at an advanced recycling facility or held at such facil-16 ity prior to conversion.

17 2. "Solid waste management facility" means any facility employed beyond the initial solid waste collection process including, but not 18 limited to, transfer stations, baling facilities, rail haul or barge 19 20 haul facilities, processing systems, including resource recovery facili-21 ties or other facilities for reducing solid waste volume, sanitary land-22 fills, facilities for the disposal of construction and demolition debris, plants and facilities for compacting, composting or pyrolization 23 24 of solid wastes, incinerators and other solid waste disposal, reduction 25 or conversion facilities, but not advanced recycling facilities.

26 5. "Advanced recycling" means a manufacturing process for the conver-27 sion of post-use polymers and recovered feedstocks into basic hydrocar-28 bon raw materials, feedstocks, chemicals, waxes, lubricants and other products through processes that include pyrolysis, gasification, depo-29 30 lymerization, catalytic cracking, reforming, hydrogenation, solvolysis, 31 and other similar technologies. The recycled products produced at advanced recycling facilities shall include, but are not limited to, 32 33 monomers, oligomers, plastics, plastics and chemical feedstocks, basic 34 and unfinished chemicals, crude oil, naphtha, waxes, lubricants, coatings, other products and basic hydrocarbons. Advanced recycling shall 35 not be considered "solid waste management," "treatment," "processing," 36 "resource recovery," "disposal," "thermal treatment or processing," 37 38 "incineration," or "combustion."

6. "Advanced recycling facility" means a facility that receives, 39 stores and converts post-use polymers and recovered feedstocks it 40 receives using advanced recycling. An advanced recycling facility shall 41 42 be a manufacturing facility subject to applicable department manufactur-43 ing regulations for air, water, waste, and land use. Advanced recycling facilities shall not be considered "solid waste management facilities," 44 "solid waste disposal, reduction or conversion facilities," "municipal 45 solid waste processing facilities, " "resource recovery facilities," 46 47 "material recovery facilities," "thermal treatment facilities," 48 "combustion facilities," or "incinerators."

49 7. "Depolymerization" means a manufacturing process where post-use 50 polymers are broken into smaller molecules such as monomers and oligom-51 ers or raw, intermediate, or final products, plastics and chemical 52 feedstocks, basic and unfinished chemicals, crude oil, naphtha, liquid 53 transportation fuels, waxes, lubricants, coatings, and other basic 54 hydrocarbons.

55 <u>8. "Gasification" means a manufacturing process through which recov-</u> 56 <u>ered feedstocks are heated and converted into a fuel and gas mixture in</u> S. 7891
