- AN ACT to amend the real property tax law, in relation to allowing certain villages to enact a tax exemption for newly constructed single-family and multi-family residential properties; and providing for the repeal of such provisions upon expiration thereof

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. The real property tax law is amended by adding a new
2	section 485-w to read as follows:
3	<u>§ 485-w. Newly constructed single-family and multi-family residential</u>
4	exemption; certain villages. 1. Single-family and multi-family residen-
5	tial properties constructed subsequent to the effective date of a local
б	law adopted pursuant to this section shall be exempt from village taxes
7	to the extent provided in this section. After a public hearing, the
8	governing board of a village with a population greater than three thou-
9	sand six hundred fifty and less than three thousand six hundred sixty,
10	based upon the latest federal decennial census may, by local law,
11	provide for the exemption of real property from taxation as provided in
12	this section. A copy of such local law shall be filed with the commis-
13	sioner and the assessor of such municipality who prepares the assessment
14	roll on which the taxes of such municipality are levied.
15	2. (a)(i) Eligible newly constructed single-family and multi-family
16	residential property shall be exempt according to the following sched-
17	<u>ule:</u>

20	after the taxable status date referred to in subdivision three of this
21	section. The assessed value of any exemption granted pursuant to this
22	section shall be entered by the assessor on the assessment roll with the
23	taxable property, with the amount of the exemption shown in a separate
24	<u>column.</u>
25	5. The provisions of this section shall apply to real property used as
26	the primary residence of the owner.
27	6. A village with a population greater than three thousand six hundred
28	fifty and less than three thousand six hundred sixty, based upon the
29	latest federal decennial census may, by local law, establish a date for
30	the commencement of effectiveness of the exemption offered pursuant to
31	this section and may provide that such amount calculated pursuant to
32	subparagraph (ii) of paragraph (a) of subdivision two of this section
33	shall not exceed three hundred seventy-five thousand dollars per proper-
34	<u>ty.</u>
35	7. A local law adopted pursuant to this section may be repealed by the
36	governing body of the applicable village. In the event of such a repeal,
37	the exemption granted pursuant to this section shall cease.
