AN ACT to amend the education law, in relation to first aid certification for coaches and staff of high school athletics

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 3001-b of the education law, as added by chapter
2 498 of the laws of 1991, is amended to read as follows:
3 § 3001-b. First aid instruction [~~mandatory~~] for coaches and staff of
4 extra-class public school athletic activities. 1. On and after the
5 effective date of this section, in addition to any provision of law or
6 rule or regulation of the department related to the requirements neces-
7 sary for teachers within the public school systems, whether certified in
8 physical education or not, to coach any extra-class athletic activity,
9 it shall be required of such teachers, except as provided in subdivision
10 two or three of this section, to hold a valid certificate of completion
11 of a course of study in first aid knowledge and skills offered by the
12 American National Red Cross and approved by the commissioner, or to meet
13 equivalent requirements as certified by the commissioner. Any such
14 course of study or equivalent requirements must include instruction in
15 the administration of adult cardiopulmonary resuscitation. Prior to the
16 start of each sports season, coaches must provide valid evidence to
17 their chief school officer that their first aid and adult cardiopulmo-
18 nary resuscitation knowledge and skills are current pursuant to the
19 requirements established by the American National Red Cross or that they
20 meet equivalent requirements as certified by the commissioner.
21 2. [~~Persons~~] Except as provided in subdivision three of this section,
22 persons who have been employed as coaches of extra-class athletic activ-
23 ities in a public school system on the effective date of this section
24 who do not hold a valid certificate of completion of a course of study
25 in first aid knowledge and skills pursuant to subdivision one of this
26 section may continue to coach such sports, provided, however, that such
27 coaches do receive such certification required in subdivision one of
28 this section as soon as practicable after the effective date of this

1 section but not later than twelve months thereafter, provided, however,
2 that the commissioner shall have the authority to establish by rule or
3 regulation an additional time schedule for compliance with this section.

4 3. A teacher or person who has been employed as a coach of extra-class
5 athletic activities in a public school system and does not hold a valid
6 certificate of completion of a course of study in first aid knowledge
7 and skills offered by the American National Red Cross or a nationally
8 recognized organization, as defined in paragraph (d) of subdivision one
9 of section three thousand-b of the public health law and approved by the
10 commissioner, pursuant to subdivision one or two of this section may
11 coach any extra-class athletic activity if there is another person or
12 staff employed by the public school system who holds such certificate
13 present with the coach at all times during the extra-class athletic
14 activities including but not limited to practices, scrimmages and during
15 competition.

16 § 2. Subdivision 1 of section 3001-b of the education law, as amended
17 by chapter 500 of the laws of 2021, is amended to read as follows:

18 1. On and after the effective date of this section, in addition to any
19 provision of law or rule or regulation of the department related to the
20 requirements necessary for teachers within the public school systems,
21 whether certified in physical education or not, to coach any extra-class
22 athletic activity, it shall be required of such teachers, except as
23 provided in subdivision two or three of this section, to hold a valid
24 certificate of completion of a course of study in first aid knowledge
25 and skills offered by a nationally recognized organization, as defined
26 in paragraph (d) of subdivision one of section three thousand-b of the
27 public health law and approved by the commissioner, or to meet equiv-
28 alent requirements as certified by the commissioner. Any such course of
29 study or equivalent requirements must include instruction in recognizing
30 signs and symptoms of cardiac arrest and sudden cardiac arrest and the
31 administration of adult cardiopulmonary resuscitation. Prior to the
32 start of each sports season, coaches must provide valid evidence to
33 their chief school officer that their first aid and adult cardiopulmo-
34 nary resuscitation knowledge and skills are current pursuant to the
35 requirements established by a nationally recognized organization, as
36 defined in paragraph (d) of subdivision one of section three thousand-b
37 of the public health law and approved by the commissioner, or that they
38 meet equivalent requirements as certified by the commissioner.

39 § 3. Section 3001-c of the education law, as added by chapter 39 of
40 the laws of 1994, is amended to read as follows:

41 § 3001-c. First aid instruction [~~mandatory~~] for coaches and staff of
42 high school extra-class nonpublic school athletic activities. 1. On and
43 after the effective date of this section, it shall be required of coach-
44 es of high school extra-class athletic activities in a nonpublic school
45 system, except as provided in subdivision two or three of this section,
46 to hold a valid certificate of completion of a course of study in first
47 aid knowledge and skills offered by the American National Red Cross and
48 approved by the commissioner, or to meet equivalent requirements as
49 certified by the commissioner. Any such course of study or equivalent
50 requirements must include instruction in the administration of adult
51 cardiopulmonary resuscitation. Prior to the start of each sports season,
52 coaches must provide valid evidence to their chief school officer that
53 their first aid and adult cardiopulmonary resuscitation knowledge and
54 skills are current pursuant to the requirements established by the Amer-
55 ican National Red Cross or that they meet equivalent requirements as
56 certified by the commissioner.

1 2. [~~Persons~~] Except as provided in subdivision three of this section,
2 persons who have been employed as coaches of high school extra-class
3 athletic activities in a nonpublic school system on the effective date
4 of this section who do not hold a valid certificate of completion of a
5 course of study in first aid knowledge and skills pursuant to subdivi-
6 sion one of this section may continue to coach such sports, provided,
7 however, that such coaches do receive such certification required in
8 subdivision one of this section as soon as practicable after the effec-
9 tive date of this section but not later than twelve months thereafter,
10 provided, however, that the commissioner shall have the authority to
11 establish by rule or regulation an additional time schedule for compli-
12 ance with this section.

13 3. A teacher or person who has been employed as a coach of extra-class
14 athletic activities in a nonpublic school system and does not hold a
15 valid certificate of completion of a course of study in first aid know-
16 ledge and skills offered by the American National Red Cross or a
17 nationally recognized organization, as defined in paragraph (d) of
18 subdivision one of section three thousand-b of the public health law and
19 approved by the commissioner, pursuant to subdivision one or two of this
20 section may coach any extra-class athletic activity if there is another
21 person or staff employed by the nonpublic school system who holds such
22 certificate present with the coach at the high school extra-class
23 athletic activities.

24 § 4. Subdivision 1 of section 3001-c of the education law, as amended
25 by chapter 500 of the laws of 2021, is amended to read as follows:

26 1. On and after the effective date of this section, it shall be
27 required of coaches of high school extra-class athletic activities in a
28 nonpublic school system, except as provided in subdivision two or three
29 of this section, to hold a valid certificate of completion of a course
30 of study in first aid knowledge and skills offered by a nationally
31 recognized organization, as defined in paragraph (d) of subdivision one
32 of section three thousand-b of the public health law and approved by the
33 commissioner, or to meet equivalent requirements as certified by the
34 commissioner. Any such course of study or equivalent requirements must
35 include instruction in recognizing signs and symptoms of cardiac arrest
36 and sudden cardiac arrest and the administration of adult cardiopulmo-
37 nary resuscitation. Prior to the start of each sports season, coaches
38 must provide valid evidence to their chief school officer that their
39 first aid and adult cardiopulmonary resuscitation knowledge and skills
40 are current pursuant to the requirements established by a nationally
41 recognized organization, as defined in paragraph (d) of subdivision one
42 of section three thousand-b of the public health law and approved by the
43 commissioner, or that they meet equivalent requirements as certified by
44 the commissioner.

45 § 5. This act shall take effect immediately provided, however that:

46 (a) the amendments to subdivision 1 of section 3001-b of the education
47 law made by section one of this act shall be subject to the expiration
48 and reversion of such subdivision pursuant to section 4 of chapter 500
49 of the laws of 2021, as amended, when upon such date the provisions of
50 section two of this act shall take effect; and

51 (b) the amendments to subdivision 1 of section 3001-c of the education
52 law made by section three of this act shall be subject to the expiration
53 and reversion of such subdivision pursuant to section 5 of chapter 500
54 of the laws of 2021, as amended, when upon such date the provisions of
55 section four of this act shall take effect.
