AN ACT to amend the elder law, in relation to annual reporting requirements of the state long-term care ombudsman

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 14 of section 218 of the elder law, as amended 2 by chapter 259 of the laws of 2018, is amended and a new subdivision 14-a is added to read as follows:

14. Annual report. On or before March thirty-first, two thousand five, 5 and annually thereafter, the state ombudsman shall submit to the gover-6 nor, commissioner of the federal administration on aging, speaker of the assembly, temporary president of the senate, director of the state office for the aging, commissioner of the department of health, and the commissioner of children and family services a report and make such 10 report available to the public:

- 11 (a) describing the activities carried out by the office of the state 12 long-term care ombudsman during the prior calendar year;
- (b) containing and analyzing data relating to complaints and condi-13 14 tions in long-term care facilities and to residents for the purpose of 15 identifying and resolving significant problems, including an examination 16 of any recurring issues in any long-term care facilities to determine 17 any systemic issues in such facilities;
- 18 (c) evaluating the problems experienced by, and the complaints made by 19 or on behalf of, residents;
- (d) containing policy recommendations and recommendations for appro-20 priate state legislation, rules and regulations and other action for the 21 22 governor and state legislature based on data collected pursuant to this 23 section, concerns raised by residents and families of residents, and 24 observations made when visiting long-term care facilities, to improve the quality of the care and life of the residents, protecting the 25 26 health, safety and welfare and rights of the residents and resolving 27 resident complaints and identified problems or barriers;

(e) containing an analysis of the success of the long-term care ombudsman program, including success in providing services to residents;

- (f) describing barriers that prevent the optimal operation of the ombudsman program;
- (g) describing any organizational conflicts of interest in the ombudsman program that have been identified and the steps taken to remove or remedy such conflicts; [and]
- (h) containing all complaints received by the state ombudsman relating to long-term care facilities, listed by facility name and by region;
- 10 <u>(i) containing the number of visits to each long-term care facility,</u>
  11 <u>listed by facility name and by region, and names of long-term care</u>
  12 <u>facilities that did not receive any visits in the prior year; and</u>
- 13 (j) any other matters as the state ombudsman, in consultation with the 14 director of the state office for the aging, determines to be appropri-15 ate.
- 14-a. Report to attorney general. Annually, upon submission of the
  annual report pursuant to subdivision fourteen of this section, the
  state ombudsman shall submit an additional report to the attorney general that shall contain general information relating to instances of
  abuse, neglect, and exploitation in long-term care facilities in a
  manner that does not violate individual resident confidentiality, for
  review and possible enforcement action.
  - § 2. This act shall take effect immediately.
