AN ACT to amend the executive law and the general municipal law, in relation to providing for local human rights laws

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Short title. This act shall be known and may be cited as
2 the "Effective Enforcement of Civil Rights Act of 2022".

3 § 2. Legislative purpose. To encourage municipalities to take advan-
4 tage of their home rule powers to proscribe discrimination and to more
5 broadly prohibit discriminatory conduct and decisions that take place,
6 in whole or in part, within a local jurisdiction, regardless of where
7 that conduct and decisions have impact.

8 § 3. Section 292 of the executive law is amended by adding a new
9 subdivision 40 to read as follows:

10 40. The term "local human rights law", when used in this article,
11 means a law of a city or of a county not wholly located within a city
12 that has delineated and proscribed local unlawful discriminatory prac-
13 tices.

14 § 4. Subdivisions 6 and 16 of section 295 of the executive law, subdivi-
15 sion 6 as amended by chapter 958 of the laws of 1968 and subdivision
16 16 as added by chapter 493 of the laws of 1970, are amended to read as
17 follows:

18 6. (a) To receive, investigate and pass upon complaints alleging
19 violations of this article and local human rights laws.

20 (b) Upon its own motion, to test and investigate and to make, sign and
21 file complaints alleging violations of this article and local human
22 rights laws, and to initiate investigations and studies to carry out the
23 purposes of this article.

3 § 5. Article 12-D of the general municipal law, as added by chapter
 4 376 of the laws of 1963, the article heading as amended by chapter 413
 5 of the laws of 1964, section 239-o, paragraph (a) of subdivision 1 of
 6 section 239-q, and subdivisions (a) and (b) of section 239-r as amended
 7 by chapter 560 of the laws of 2019, sections 239-q, 239-r, 239-s and
 8 239-t as amended by chapter 958 of the laws of 1968, is amended to read
 9 as follows:

24 § 239-o. Enactment and enforcement of local human rights laws. 1. The
 25 legislative body of any city or any county not wholly located within a
 26 city, may:

27 (a) enact such legislation as it sees fit to define, proscribe, and
 28 remedy local unlawful discriminatory practices;

29 (b) determine whether such legislation is to be enforced administra-
 30 tively or through an action commenced in a court of general jurisdic-
 31 tion; and

32 (c) determine which persons and entities are permitted to seek
 33 enforcement.

34 2. Such local laws shall be enforceable by or on behalf of all persons
 35 whether or not those persons are residents of the city or county in
 36 question, and whether or not those persons are residents of the state,
 37 so long as the discriminatory conduct or decision-making occurs, in
 38 whole or in part, within the geographic bounds of such city or county in
 39 question. Such local laws shall also be enforceable by or on behalf of
 40 residents of the city or county in question even where neither the
 41 discriminatory conduct nor decision-making occurs within the geographic
 42 bounds of the city or county; provided that the discriminatory conduct
 43 or decision-making is the act of a resident of this state or an act of a
 44 corporation organized under the laws of this state or authorized to do
 45 business in this state.

46 § 239-p. Creation, appointment and terms of commissions on, and
 47 departments of, human rights. The governing board of any county, city,
 48 village or town may by resolution create a commission on, or department
 49 of, human rights. [~~The~~] In the case of creating a commission, the
 50 governing board shall determine the number of members of such commis-
 51 sion, the terms of the members, the manner of appointment of the
 52 members, the selection of a chairman and the compensation, if any, to be
 53 paid to them. In selecting the membership of the commission, the govern-
 54 ing board shall take into consideration the various ages, races, creed,
 55 color, national origin, sexual orientation, gender identity or
 56 expression, military status, sex, disability, predisposing genetic char-

acteristics, familial status, marital status, domestic violence victim status and political groups in the community. The establishment of such a commission at one level of local government shall not preclude establishment of such a commission at other levels of local government.

§ ~~[239-p]~~ 239-g. Officers and employees; expenses. ~~[The]~~ A commission shall have the power and authority to employ an executive director, a secretary and such attorneys, experts and other employees as may be necessary, within the amount made available by the local governing board. Each county, city, village and town is hereby authorized and empowered to make such appropriation for such expenses and for the compensation, if any, to be paid to the members of the commission. A city or county shall have the power and authority to employ staff and expend funds in respect to departments of human rights as it does in respect to any other municipal department.

§ ~~[239-q]~~ 239-r. General duties ~~[and]~~, powers, and obligations. 1. It shall be the duty of ~~[the]~~ a commission:

(a) To foster mutual respect and understanding among all ages, races, creed, color, national origin, sexual orientation, gender identity or expression, military status, sex, disability, predisposing genetic characteristics, familial status, marital status and domestic violence victim status groups in the community.

(b) To make such studies in any field of human relationship in the community as in the judgment of the commission will aid in effectuating its general purposes and where desirable, to make the results of such studies public.

(c) To inquire into incidents of tension and conflict among or between various racial, religious and nationality groups, and to take such action as may be designed to alleviate such tensions and conflict.

(d) To conduct and recommend such educational programs as, in the judgment of the commission, will increase goodwill among inhabitants of the community and open new opportunities into all phases of community life for all inhabitants.

2. In addition to all other powers, ~~[the]~~ a commission, where and to the extent authorized by local law or ordinance, shall have the power:

~~[a-]~~ (a) To report complaints to the division of human rights alleging unlawful discriminatory practices under article fifteen of the executive law.

~~[b-]~~ (b) To receive, accept and use and expend public grants and private gifts, donations or bequests and other payments, goods and services, notwithstanding any other provision of law.

~~[§ 239-r. General obligations.]~~ 3. A commission on human rights created under the provisions of section two hundred ~~[thirty-nine-o]~~ thirty-nine-p of this article shall discharge the following obligations~~[+]~~:

(a) To receive complaints of alleged discrimination because of an individual's age, race, creed, color or national origin, sexual orientation, gender identity or expression, military status, marital status, sex, disability, predisposing genetic characteristics, familial status, marital status or domestic violence victim status, to seek the active assistance of the division of human rights in the solution of complaints which fall within the jurisdiction of the division and to prepare its own plans in the case of other complaints with a view to reducing and eliminating such alleged discrimination through the process of conference, conciliation and persuasion.

(b) To hold conferences, and other public meetings in the interest of the constructive resolution of age, race, creed, color, national origin,

1 sexual orientation, gender identity or expression, military status, sex,
2 disability, predisposing genetic characteristics, familial status, mari-
3 tal status and domestic violence victim status group tensions and the
4 prejudice and discrimination occasioned thereby.

5 (c) To issue such publications and reports of investigation as in its
6 judgment will tend to effectuate the purposes of this article.

7 (d) To enlist the cooperation and participation of the various racial,
8 religious and nationality groups, community organizations, industry and
9 labor organizations media or mass communication, fraternal and benevo-
10 lent associations, and other groups in an educational campaign devoted
11 to fostering among the diverse groups of the community mutual esteem,
12 justice and equity and opening new opportunities into all phases of
13 community life for all individuals.

14 (e) To encourage and stimulate agencies under the jurisdiction of the
15 governing board which created the commission to take such action as will
16 fulfill the purposes of this article.

17 (f) To submit an annual report to the governing board or boards and to
18 furnish a copy thereof to the division of human rights.

19 § 239-s. [~~New York city commission on human rights~~] Powers not limit-
20 ed; concurrent jurisdiction. Nothing in this article shall be deemed to
21 limit or reduce the powers of the New York city commission on human
22 rights[, ~~and with respect to such powers, the jurisdiction of the New~~
23 ~~York city commission on human rights in relation to matters within the~~
24 ~~city of New York shall be~~] or the scope and coverage of the New York
25 city human rights law. The jurisdiction and powers exercised or to be
26 exercised under local human rights laws, commissions and departments are
27 deemed to be concurrent with the jurisdiction of the New York state
28 division of human rights in respect to the conduct and decision-making
29 set out in subdivision two of section two hundred thirty-nine-o of this
30 article.

31 § 239-t. Filing copies. One copy each of any resolution, ordinance or
32 local law which has been, or which may hereafter be adopted, creating a
33 commission on human rights, or any amendment thereto, shall, on or
34 before September first, nineteen hundred sixty-seven, or within five
35 days after its adoption, be filed with the division of human rights.

36 § 6. This act shall take effect immediately.
