- AN ACT to amend chapter 476 of the laws of 1957 relating to authorizing the board of commissioners of the land office to grant certain easements in lands of the State University Agricultural and Technical Institute at Farmingdale to Central Hudson Gas and Electric Corporation, in relation to the description of lands for which the Commissioner of General Services is authorized to grant an easement to the Central Hudson Gas and Electric Corporation

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Sections 1 and 2 of chapter 476 of the laws of 1957, 2 relating to authorizing the board of commissioners of the land office to grant certain easements in lands of the State University Agricultural 3 and Technical Institute at Farmingdale to Central Hudson Gas and Elec-4 5 tric Corporation, are amended to read as follows: б § 1. The [board of commissioners of the land office, with] Commission-7 er of General Services, upon the consent [and approval of the board of 8 trustees of State University of New York] of the Commissioner of the Department of Environmental Conservation, is hereby authorized to grant 9 10 and convey to the Central Hudson Gas and Electric Corporation, [a domes-11 tic corporation organized and existing under the laws of the State of 12 New York, easements in and across two parcels of land of the State 13 University Agricultural and Technical Institute at Farmingdale, hereinafter described in section two of this act, an easement of state lands 14 more accurately described in section two of this act, consisting of a 15 16 portion of the Stony Kill Farm Environmental Education Center under the 17 jurisdiction of the Department of Environmental Conservation for the 18 purpose of constructing and maintaining electric transmission lines, 19 upon such terms and conditions [including consideration as the board of 20 commissioners of the land office may fix and determine] deemed necessary 21 and appropriate.

§ 2. [The lands in which the easements are authorized to be granted 1 2 and conveyed may be surveyed by the New York State Department of Public 3 Works for a more accurate description and may be granted and conveyed 4 according to such survey, but are generally described as follows: All 5 those two parcels of land situate in the Towns of Fishkill and Wapping-6 er, County of Dutchess and State of New York, bounded and described as 7 follows: Parcel 1. Beginning at a point in the property line and center-8 line of the Baxtertown Road between he lands of the State of New York and Julius Moeller and at the southwesterly corner of lands of Ham, said 9 10 point being distant seventy-five feet easterly (measured at right 11 angles) from the survey centerline of the proposed central Hudson Cas and Electric Corporation electric transmission line, thence south eight-12 y-four degrees zero minutes west one hundred fifty-six and four tenths 13 14 feet along the aforesaid property line and centerline of the said road, 15 thence north ten degrees twenty-four minutes east three hundred sixtythree and eight tenths feet, more or less, parallel to and distant 16 17 seventy-five feet westerly (measured at right angles) from the aforesaid survey centerline to a point opposite an angle point in the aforemen-18 tioned transmission line, thence north eleven degrees fifty-two minutes 19 20 west nine hundred sixty-two and three tenths feet, more or less, parallel and distant seventy-five feet westerly (measured at right angles) 21 from the aforesaid survey centerline to a point opposite an angle point 22 in he aforementioned transmission line, thence north fifty-three degrees 23 fifty-seven minutes east eight hundred nineteen and seven tenths feet, 24 more or less, parallel and distant seventy-five feet northwesterly 25 (measured at right angles) from the aforesaid survey centerline to a 26 27 point opposite an angle in the aforementioned transmission line, thence north eleven degrees eight minutes west thirteen hundred fifteen and 28 four tenths feet, more or less, parallel and distant seventy-five feet 29 westerly (measured at right angles) from the aforesaid survey centerline 30 to a point in the property line stonewall between the lands of the State 31 32 of New York and Edward M. Husted, thence north sixty-nine degrees four-33 teen minutes cast one hundred fifty-two and fourteen hundredths feet along the said property line stonewall and across the aforesaid survey 34 centerline, thence south eleven degrees eight minutes east fourteen 35 hundred thirty six and six tenths feet, more or less, parallel and 36 distant seventy-five feet easterly (measured at right angles) from the 37 aforesaid survey centerline to a point opposite an angle point in the 38 aforementioned transmission line, thense south fifty-three degrees 39 fifty-seven minutes west eight hundred eighteen and three tenths feet, 40 more or less, parallel and distant seventy-five feet southeasterly 41 42 (measured at right angles) from the aforesaid survey centerline to a 43 point in a dirt road in range with the sourtherly property line stone-44 wall of lands of the State of New York, said point also being opposite 45 an angle point in the aforementioned transmission line, thence south eleven degrees fifty-two minutes east eight hundred ninety-for and eight 46 47 tenths feet, more or less, parallel and distant seventy-five feet east-48 erly (measured at right angles) from the aforesaid survey centerline to a point opposite an angle point in the aforementioned transmission line, 49 thence south ten degrees twenty-four minutes west three hundred forty-50 51 nine and one tenth feet, more or less, parallel and distant seventy five 52 feet easterly (measured at right angles) from the aforesaid survey centerline to the place of beginning, containing eleven and ninety-eight 53 54 hundredths acres, more or less. Parcel 2. Beginning at a southeasterly corner of the lands of the State of New York approximately three hundred 55
