- Introduced by Sen. SALAZAR -- read twice and ordered printed, and when printed to be committed to the Committee on Local Government
- AN ACT to authorize the city of New York to discontinue the use as parkland a portion of real property in the borough of Brooklyn and to use such property to construct elevators and handicapped accessible improvements and upgrades to the New York city transit authority Broadway Junction transit station

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subject to the provisions of this act, but notwithstanding 1 any provision of state or local law to the contrary, the city of New 2 York is hereby authorized to: (a) discontinue permanently the use as 3 4 parklands the lands described in section three of this act, and transfer 5 such lands to the metropolitan transportation authority, to enable the б New York city transit authority to construct in such areas new permanent 7 at-grade station improvements; (b) discontinue permanently the use as 8 parklands the lands described in section four of this act, and transfer 9 such lands to the metropolitan transportation authority to enable the 10 New York city transit authority to improve such airspace above parklands 11 with pedestrian bridges between and among the L, J, Z, A and C subway 12 lines; (c) discontinue permanently the use as parklands certain portions 13 of the areas described in section four of this act, and to grant proper-14 ty rights, including subsurface and above surface rights to the metro-15 politan transportation authority to the extent needed for structural supports for above grade transit station improvements; and (d) discon-16 tinue temporarily the use as parklands land described in sections three, 17 four and five of this act and to grant a temporary easement to the 18 19 metropolitan transportation authority; such discontinuance of the use as 20 parklands shall be to enable the New York city transit authority to 21 engage in construction of elevators, handicap accessible improvements 22 and other upgrades to the Broadway Junction transit station and temporary construction ingress and egress. Such aforesaid conveyances shall 23 24 be granted upon such terms and conditions as the city of New York and 25 the metropolitan transportation authority shall determine, including

terms and conditions for the metropolitan transportation authority to 1 ensure that the city of New York can comply with section seven of this 2 3 act. The metropolitan transportation authority, as consideration for 4 § 2. 5 being granted easements described in this act, shall pay to the city of 6 New York the fair market value of the parklands being discontinued. The 7 authorization provided in section one of this act shall be effective 8 only upon the condition that the city of New York dedicates an amount 9 equal to or greater than the fair market value payable by the metropol-10 itan transportation authority, as such fair market value is determined 11 in such easements, for the parklands being discontinued towards the 12 acquisition of new parklands or capital improvements to existing parklands and recreational facilities within the borough of Brooklyn. 13 14 § 3. 22 § 7. The discontinuance of parkland authorized by this act shall not 23 occur until the city of New York has complied with any applicable federrequirements pertaining to the alienation or conversion of the park-24 al 25 lands, including satisfying the secretary of the interior that the 26 conversion complies with all conditions which the secretary of the inte-27 rior deems necessary to ensure the provision of adequate recreation 28 properties and opportunities of reasonably equivalent location and 29 usefulness.

§ 8. Upon the completion of construction, the metropolitan transportation authority shall, in agreement with the city of New York and in consultation with the local community board, restore the surface of the lands described in sections four and five of this act, other than those areas described in section four of this act on which structural supports are located to support the aerial improvements to be constructed, and the lands shall otherwise continue to be used for park purposes. § 9. This act shall take effect immediately.
