AN ACT to amend the vehicle and traffic law and the public authorities law, in relation to authorizing a residential parking permit system in the city of New York; and providing for the repeal of such provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Legislative findings and intent. The legislature finds that a lack of parking for residents of the city of New York has resulted in traffic hazards, congestion and air and noise pollution. In addition, such lack of parking poses a hazard to residents and other pedestrians in such areas.

6 The legislature further finds that a residential parking system will 7 reduce such hazards and will reduce pollution levels as well. The legis-8 lature, therefore, declares the necessity of this act to authorize the 9 city of New York to adopt a residential parking system in accordance 10 with the provisions of this act.

11 § 2. The vehicle and traffic law is amended by adding a new section 12 1640-s to read as follows:

13 <u>§ 1640-s. Residential parking system in the city of New York. 1.</u>
14 Notwithstanding the provisions of any law to the contrary, the city of
15 New York may, by adoption of a local law or ordinance, provide for a
16 residential parking permit system and fix and require the payment of
17 fees applicable to parking within the area of the city in which such
18 parking system is in effect in accordance with the provisions of this
19 section.
20 2. Such residential parking permit system may only be established

21 within that area of the city of New York within the neighborhoods of 22 Clinton Hill, Fort Greene, Prospect Heights, Park Slope, Gowanus,
