AN ACT to amend the environmental conservation law, in relation to making contests, competitions, tournaments and derbys to take wildlife unlawful

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivisions 14, 15 and 16 of section 11-0901 of the envi-2 ronmental conservation law, subdivision 14 as renumbered by chapter 486 3 of the laws of 1985, are renumbered subdivisions 15, 16 and 17 and a new 4 subdivision 14 is added to read as follows:

5 14. It shall be unlawful for any person to organize, sponsor, conduct, б promote, or participate in any contest, competition, tournament, or 7 derby with the objective of taking or hunting wildlife for prizes or 8 other inducement, or for entertainment. The remains of any wildlife killed during the course of a contest, competition, tournament, or derby 9 10 conducted in violation of this subdivision shall be forfeited by every 11 organizer, promoter, participant or any other person conducting or 12 involved in such contest, competition, tournament, or derby and the 13 remains of such wildlife shall become the property of the department. The provisions of this subdivision shall not apply to: (a) any contest, 14 competition, tournament, or derby with the object of taking or hunting 15 16 white-tailed deer, turkey, or bear; or (b) special dog training areas or field trials pursuant to sections 11-0925 and 11-0927 of this title, or 17

18 any similar canine performance events.

19 § 2. Section 71-0921 of the environmental conservation law is amended 20 by adding a new subdivision 10-a to read as follows:
