AN ACT to amend the public health law, in relation to the adult cystic fibrosis assistance program

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The public health law is amended by adding a new article 27-g to read as follows:

ARTICLE 27-G

ADULT CYSTIC FIBROSIS ASSISTANCE PROGRAM

 - § 2795. Adult cystic fibrosis assistance program. 1. The commissioner shall establish a program to reimburse the cost of providing health care or health insurance to eliqible individuals who have cystic fibrosis.

- 15 <u>(d) shall not be eligible for medical benefits under any group or</u> 16 <u>individual health insurance policy; and</u>
- 17 <u>(e) shall not be eligible for medical assistance pursuant to title</u>
 18 <u>eleven of article five of the social services law solely due to earned</u>

 20 3. To be a partially eligible individual for whom health care will be
 21 provided under this section, such individual shall meet all the criteria
- of a fully eligible individual except that a partially eligible individual shall be an individual who is eligible for medical benefits under

- 25 <u>all services necessary for the care and treatment of cystic fibrosis.</u>

The commissioner shall require each fully eligible individual, upon determination of eligibility, to make application to a private health insurance provider as prescribed by the commissioner for an individual health insurance policy. If and when such policy is granted, the commissioner shall approve payment for the associated premium.

- 5. The commissioner shall authorize payment for services related to the care and treatment of cystic fibrosis not otherwise covered by a health insurance policy. Providers of such services shall be reimbursed at the same rate and claims for payment shall be made as if such individual was eligible for benefits pursuant to title eleven of article five of the social services law.
- 12 <u>6. All eligible individuals shall be required to contribute seven</u>
 13 <u>percent of their net annual income toward the cost of care and/or the</u>
 14 <u>cost of the annual health insurance premium.</u>
- 7. The commissioner shall, in consultation with the commissioner of social services, promulgate rules and regulations necessary to implement the provisions of this article.
