AN ACT to amend the vehicle and traffic law, in relation to authorizing cities, villages and towns to reduce the speed limit to less than twenty-five miles per hour in areas designated for senior citizens

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 1643 of the vehicle and traffic law, as amended by 2 chapter 496 of the laws of 2022, is amended to read as follows:

3 § 1643. Speed limits on highways in cities and villages. The legisla-4 tive body of any city or village with respect to highways (which term for the purposes of this section shall include private roads open to 5 public motor vehicle traffic) in such city or village, other than state б 7 highways maintained by the state on which the department of transporta-8 tion shall have established higher or lower speed limits than the statu-9 tory fifty-five miles per hour speed limit as provided in section 10 sixteen hundred twenty of this title, or on which the department of 11 transportation shall have designated that such city or village shall not 12 establish any maximum speed limit as provided in section sixteen hundred 13 twenty-four of this title, subject to the limitations imposed by section 14 sixteen hundred eighty-four of this title may by local law, ordinance, order, rule or regulation establish maximum speed limits at which vehi-15 cles may proceed within such city or village, within designated areas of 16 such city or village or on or along designated highways within such city 17 village higher or lower than the fifty-five miles per hour maximum 18 or 19 statutory limit. No such speed limit applicable throughout such city or 20 village or within designated areas of such city or village shall be 21 established at less than twenty-five miles per hour; except that (i) the 22 legislative body of any city or village may by local law, ordinance, 23 order, rule or regulation establish a speed limit less than twenty-five 24 miles per hour but not less than fifteen miles per hour applicable in

areas designated for senior citizens of such city or village, including 1 but not limited to, senior citizen centers and senior citizen housing 2 complexes, and (ii) in the city of Long Beach, in the county of Nassau, 3 4 speed limits may be established at not less than fifteen miles per hour 5 on any portion of the following highways in such city: Cleveland avenue, 6 Harding avenue, Mitchell avenue, Belmont avenue, Atlantic avenue, Cool-7 idge avenue, Wilson avenue and Taft avenue. No such speed limit applica-8 ble on or along designated highways within such city or village shall be 9 established at less than twenty-five miles per hour, except that school 10 speed limits may be established at not less than fifteen miles per hour, 11 for a distance not to exceed one thousand three hundred twenty feet, on 12 a highway passing a school building, entrance or exit of a school abut-13 ting on the highway and except that within the cities of Buffalo and 14 Rochester speed limits may be established at not less than fifteen miles 15 per hour for any portion of a highway within a city park. No speed 16 limits shall be established pursuant to the provisions of this section 17 except in accordance with the engineering considerations and factors for speed limits set forth in the manual and specifications for a uniform 18 system of traffic control devices maintained by the commissioner of 19 20 transportation pursuant to section sixteen hundred eighty of this title, 21 such manual and specifications may be amended from time to time, as 22 certified by a licensed professional engineer who specializes in traffic 23 operations. 24 § 2. Section 1662-a of the vehicle and traffic law, as amended by 25 chapter 496 of the laws of 2022, is amended to read as follows: 26 § 1662-a. Speed limits in certain towns. The town board of any subur-27 ban town governed pursuant to article three-A of the town law and the 28 town board of any other town having a population exceeding fifty thou-29 sand, with respect to highways (which term for the purposes of this 30 section shall include private roads open to public motor vehicle traf-31 fic) in such towns outside any village, other than state highways main-32 tained by the state on which the department of transportation shall have 33 established higher or lower speed limits than the statutory fifty-five 34 miles per hour speed limit as provided in section sixteen hundred twenty 35 of this title, or on which the department of transportation shall have 36 designated that such towns shall not establish any maximum speed limit 37 as provided in section sixteen hundred twenty-four of this title, 38 subject to the limitations imposed by section sixteen hundred eighty-39 four of this title may by local law, ordinance, order, rule or regulation establish maximum speed limits at which vehicles may proceed 40 within such towns, within designated areas of such towns or on or along 41 42 designated highways within such towns lower than the fifty-five miles 43 per hour maximum statutory limit. No such speed limit applicable 44 throughout such towns or within designated areas of such towns shall be 45 established at less than twenty-five miles per hour, except that (i) a 46 town board may by local law, ordinance, order, rule or regulation estab-47 lish a speed limit less than twenty-five miles per hour but not less 48 than fifteen miles per hour applicable in areas designated for senior citizens of such town, including but not limited to, senior citizen 49 centers and senior citizen housing complexes, and (ii) in the town of 50 51 Hempstead speed limits may be established at not less than fifteen miles 52 per hour on any portion of a highway in the community known as Point 53 Lookout and on all or any portion of the following highways in the 54 community known as Lido Beach: Ocean Boulevard, Allevard Street, Bath Street, Buxton Street, Cheltenham Street, Pinehurst Street, Harrogate 55 Street, Matlock Street, Nantwick Street, Biarritz Street, Royat Street, 56

Luchon Street, Woodhail Street, Leamington Street, Saratoga Street, 1 2 Kensington Street, and Prescott Street; provided, however, that no such speed limit in such town may be established unless a majority of the 3 4 residents of each such community file a petition with the town board of 5 such town requesting such speed limit. No such speed limit applicable on б or along designated highways within such towns shall be established at 7 less than twenty-five miles per hour, except that school speed limits 8 may be established at not less than fifteen miles per hour, for a 9 distance not to exceed one thousand three hundred twenty feet, on a 10 highway passing a school building, entrance or exit of a school abutting 11 on the highway, and except further that in the town of Hempstead speed 12 limits may be established at not less than fifteen miles per hour on any 13 portion of a highway in the communities known as Point Lookout and Lido 14 Beach; provided, however, that no such speed limit in such town may be 15 established unless a majority of the residents of each such community 16 file a petition with the town board of such town requesting such speed 17 limit. No speed limits shall be established pursuant to the provisions of this section except in accordance with the engineering considerations 18 19 and factors for speed limits set forth in the manual and specifications 20 for a uniform system of traffic control devices maintained by the 21 commissioner of transportation pursuant to section sixteen hundred 22 eighty of this title, as such manual and specifications may be amended from time to time, certified by a licensed professional engineer who 23 24 specializes in traffic operations.

25 § 3. This act shall take effect immediately.
