AN ACT to amend the mental hygiene law, in relation to developing materials relating to suicide prevention for school-aged children, and to amend the education law, in relation to including suicide prevention in health education curriculum

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 7.07 of the mental hygiene law is amended by adding
a new subdivision (i) to read as follows:

3 (i) The office shall, in consultation with the education department, identify or develop materials for educators regarding suicide prevention 4 5 measures and signs of depression among school-aged children which may be б used by school districts and boards of cooperative educational services, 7 at their option, to educate students about such topics as such districts 8 and boards deem appropriate. Such educational materials shall include, 9 but not be limited to, information regarding symptoms of depression, how depression manifests itself in different cultures, warning signs of 10 suicide, actions to take once a child is identified as a risk of 11 12 suicide, social media safety and the prevention of cyberbullying, and a 13 list of educational websites regarding suicide and children. Such mate-14 rial shall be available on the education department's website. The 15 office shall provide a hyperlink on its website to the page of the education department's website that displays such materials. 16
