AN ACT to amend the vehicle and traffic law, in relation to the disqualification of school bus drivers for certain offenses involving children

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 4 of section 509-cc of the vehicle and traffic law, as amended by chapter 400 of the laws of 2011, paragraph (a) as amended by chapter 189 of the laws of 2018 and paragraph (c) as amended by chapter 92 of the laws of 2021, is amended to read as follows:
