Introduced by M. of A. HAWLEY -- read once and referred to the Committee on Governmental Employees

AN ACT in relation to granting retroactive membership with Tier IV status in the New York state and local employees' retirement system to Ronald Bower

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Notwithstanding any other provision of the law to the  
2 contrary, Ronald Bower, an employee of the Genesee County Highway  
3 Department and a member of the New York state and local employees'  
4 retirement system, who was employed in the Occupational Skills Program  
5 at Erie 1 BOCES beginning November 12, 1986 through July 6, 1988, who  
6 for reasons not ascribable to his own negligence, failed to become a  
7 member of such retirement system when first employed by Erie 1 BOCES  
8 beginning in 1986, shall be deemed to have been a member of the New York  
9 state and local employees' retirement system on such date that he  
10 commenced his employment with Erie 1 BOCES on November 12, 1986, and  
11 shall be granted Tier IV status in such retirement system, provided that  
12 an application is filed with the head of the New York state and local  
13 employees' retirement system within one year from the effective date of  
14 this act. Upon the granting of such retroactive membership, Ronald Bower  
15 shall not be granted a refund of any employee contribution made by him  
16 to the New York state and local employees' retirement system.

17 § 2. No contributions made to the New York state and local employees'  
18 retirement system by Ronald Bower shall be returned or refunded to him  
19 pursuant to this act.

20 § 3. All past service costs associated with the implementation of this  
21 act shall be borne by Erie 1 BOCES.

22 § 4. This act shall take effect immediately.

This bill would grant retroactive Tier 4 status in the New York State and Local Employees' Retirement System to Ronald Bower, a current Tier 6 member employed by the Genesee County Highway Department, by changing their date of membership to November 12, 1986, when they were first employed by Erie 1 BOCES. There will be no refund of member contributions.

If this bill is enacted during the 2023 legislative session, we anticipate that there will be an increase of approximately \$3,200 in the annual contributions of Genesee County for the fiscal year ending March 31, 2024. In future years, this cost will vary as the billing rates and salary of Ronald Bower change.

In addition to the annual contributions discussed above, there will be an immediate past service cost of approximately \$8,040 which will be borne by Erie 1 BOCES as a one-time payment. This estimate assumes that payment will be made on February 1, 2024.

Summary of relevant resources:

Membership data as of March 31, 2022 was used in measuring the impact of the proposed change, the same data used in the April 1, 2022 actuarial valuation. Distributions and other statistics can be found in the 2022 Report of the Actuary and the 2022 Annual Comprehensive Financial Report.

The actuarial assumptions and methods used are described in the 2020, 2021, and 2022 Annual Report to the Comptroller on Actuarial Assumptions, and the Codes, Rules and Regulations of the State of New York: Audit and Control.

The Market Assets and GASB Disclosures are found in the March 31, 2022 New York State and Local Retirement System Financial Statements and Supplementary Information.

I am a member of the American Academy of Actuaries and meet the Qualification Standards to render the actuarial opinion contained herein.
