AN ACT to amend the social services law, in relation to expanding the membership of the interagency task force on trafficking in persons; and to amend chapter 74 of the laws of 2007 amending the penal law, the criminal procedure law, the correction law, the social services law and the executive law relating to human trafficking, in relation to extending the interagency task force on human trafficking

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision (a) of section 483-ee of the social services law, as amended by chapter 413 of the laws of 2016, is amended to read as follows:

(a) There is established an interagency task force on trafficking in persons, which shall consist of the following members or their designees: (1) the commissioner of the division of criminal justice services; (2) the commissioner of the office of temporary and disability assistance; (3) the commissioner of health; (4) the commissioner of the office of mental health; (5) the commissioner of labor; (6) the commissioner of the office of children and family services; (7) the commissioner of the office of ~~[alcoholism and substance abuse]~~ addiction services and supports; (8) the director of the office of victim services; (9) the executive director of the office for the prevention of domestic violence; ~~[and]~~ (10) the superintendent of the division of state police; (11) the secretary of state; (12) the commissioner of the department of transportation; (13) the commissioner of the department of motor vehicles; (14) the executive director of the New York state thruway authority; and the following additional members, who shall be promptly appointed by the governor, each for a term of two years, provided that such person's membership shall continue after such two year term until a

1 successor is appointed and provided, further, that a member may be reap-  
2 pointed if again recommended in the manner specified in this subdivi-  
3 sion: [~~(11)~~] (15) two members, who shall be appointed on the recommenda-  
4 tion of the temporary president of the senate; [~~(12)~~] (16) two members,  
5 who shall be appointed on the recommendation of the speaker of the  
6 assembly; [~~(13)~~] (17) two members, who shall be appointed on the recom-  
7 mendation of the not-for-profit organization in New York state that  
8 receives the largest share of funds, appropriated by and through the  
9 state budget, for providing services to victims of human trafficking, as  
10 shall be identified annually in writing by the director of the budget;  
11 and [~~(14)~~] (18) one member, who shall be appointed on the recommendation  
12 of the president of the New York state bar association; and others as  
13 may be necessary to carry out the duties and responsibilities under this  
14 section. The task force will be co-chaired by the commissioners of the  
15 division of criminal justice services and the office of temporary and  
16 disability assistance, or their designees. It shall meet as often as is  
17 necessary, but no less than three times per year, and under circum-  
18 stances as are appropriate to fulfilling its duties under this section.  
19 All members shall be provided with written notice reasonably in advance  
20 of each meeting with date, time and location of such meeting.

21 § 2. Section 14 of chapter 74 of the laws of 2007 amending the penal  
22 law, the criminal procedure law, the correction law, the social services  
23 law and the executive law relating to human trafficking, as amended by  
24 chapter 227 of the laws of 2021, is amended to read as follows:

25 § 14. This act shall take effect on the first of November next  
26 succeeding the date on which it shall have become a law; provided that  
27 section 483-ee of the social services law, as added by section eleven of  
28 this act, shall take effect immediately and shall remain in full force  
29 and effect until September 1, [~~2023~~] 2027 when upon such date the  
30 provisions of such section shall expire and be deemed repealed.  
31 Provided, effective immediately, the addition, amendment and/or repeal  
32 of any rule or regulation necessary for the timely implementation of the  
33 provisions of article 10-D of the social services law, as added by  
34 section eleven of this act, on its effective date are authorized to be  
35 made on or before such effective date.

36 § 3. This act shall take effect immediately, provided, however, that  
37 the amendments to section 483-ee of the social services law made by  
38 section one of this act shall not affect the expiration and repeal of  
39 such section and shall be deemed repealed therewith.
