Committee on Environmental Conservation

AN ACT to extend a term estate and making certain other changes relating  
to property known as Henry Kaufmann Campgrounds in the borough of  
Staten Island, city of New York

The People of the State of New York, represented in Senate and Assem-  
bly, do enact as follows:

1 Section 1. This act affects certain real property known as and oper-  
2 ated as a part of the Henry Kaufmann Campgrounds in Staten Island, New  
3 York that was acquired, subject to the reservation of certain rights by  
4 the grantor, from United Jewish Appeal-Federation of Jewish Philanthro-  
5 pies of New York, Inc. (hereinafter "UJA"), a New York not-for-profit  
6 corporation, by The People of the State of New York, acting by and  
7 through the commissioner of environmental conservation (hereinafter the  
8 "commissioner") pursuant to a deed (hereinafter the "deed") dated Janu-  
9 ary 3, 1990, and recorded in the Richmond county clerk's office on Janu-  
10 ary 4, 1990 in book 2321, Page 102, which real property is described  
11 more particularly in section two of this act. The deed references and is  
12 subject to that certain "Agreement Providing for Reservation of a Term  
13 Estate by the Grantor of Real Property Being Acquired by the People of  
14 the State of New York Under Article 3, Title 3, Section 3-0305 of the  
15 Environmental Conservation Law", between UJA and The People of the State  
16 of New York, acting by and through the commissioner (hereinafter the  
17 "agreement"), dated December 28, 1989, and recorded in the Richmond  
18 county clerk's office on January 4, 1990, in Book 2321, Page 134.

19 § 2. The real property that is the subject of the deed and the agree-  
20 ment is described in the deed as follows (in the deed the term "Grantor"  
21 means UJA, and the term "Grantee" means The People of the State of New  
22 York, acting by and through the commissioner):

23 ALL THAT PIECE OR PARCEL OF LAND, LYING, SITUATE AND BEING in the  
24 borough of Richmond (Staten Island), County of Richmond, City and State

1 of New York and being more particularly bounded and described as  
2 follows:

3 BEGINNING at a point on the southeasterly margin of Manor Road at its  
4 intersection with the northeasterly margin of Yates Avenue, a paper  
5 street; thence northeasterly, northerly, northeasterly and northerly  
6 along the margin of Manor Road, the following five (5) courses and  
7 distances:

8 1) North 24 degrees 25 minutes 39 seconds East, 1,276.61 feet to a  
9 point;

10 2) North 49 degrees 23 minutes 26 seconds East, 109.29 feet to a  
11 point;

12 3) North 03 degrees 23 minutes 00 seconds West, 30.38 feet to a point;

13 4) North 49 degrees 35 minutes 00 seconds East, 640.81 feet to a  
14 point;

15 5) North 02 degrees 32 minutes 40 seconds West, 139.45 feet to a  
16 point; said point being the southwesterly corner of lands now or former-  
17 ly of Joseph Piccolomini and Angelina C. Piccolomini by deed dated  
18 December 17, 1962 and recorded in Liber 1594 of Deeds at page 5 in the  
19 Richmond County Clerk's Office; thence along the previously mentioned  
20 lands, North 88 degrees 32 minutes 20 seconds East, 128.03 feet to a  
21 point in the westerly margin of lands now or formerly of Laura Destefano  
22 by deed dated April 22, 1982 and recorded on Reel 6 of deeds at page 564  
23 on June 11, 1982 in the Richmond Country Clerk's Office; thence souther-  
24 ly along the westerly margins of lands now or formerly Destefano, Alva-  
25 rado and Nilsen, South 01 degrees 27 minutes 40 seconds East, 150.00  
26 feet to the southwesterly corner of lands now or formerly of Arne J.  
27 Nilsen and Kari H. Nilsen by deed dated August 16, 1957 and recorded in  
28 Liber 1400 of Deeds at page 340 in the Richmond County Clerk's Office;  
29 thence continuing along the lands of Nilsen, North 88 degrees 32 minutes  
30 20 seconds East, 100.00 feet to the westerly margin of Peru Street;  
31 thence southerly along the westerly margin of Peru Street, South 01  
32 degrees 27 minutes 40 seconds East, 915.00 feet to a point; thence east-  
33 erly along the southerly margin of Pitt Avenue, North 88 degrees 32  
34 minutes 20 seconds East, 520.00 feet to a point in the easterly margin  
35 of Bogert Avenue; thence northerly along the easterly margin of Bogert  
36 Avenue, North 01 degrees 27 minutes 40 seconds West, 235.00 feet to a  
37 point in the southerly margin of Morse Avenue; thence easterly along the  
38 southerly margin of Morse Avenue, North 88 degrees 32 minutes 20 seconds  
39 East, 281.28 feet to the westerly margin of lands now or formerly known  
40 as the Richmond Parkway; thence southerly along the westerly margin of  
41 said Richmond Parkway, South 05 degrees 43 minutes 52 seconds East,  
42 235.66 feet to a point; thence continuing southerly and along the  
43 westerly margin of the Richmond Parkway on a curve to the right having a  
44 radius of 1328.72 feet, central angle of 10 degrees 45 minutes 13  
45 seconds, 249.38 feet to a point of compound curvature; thence continuing  
46 southerly along the westerly margin of said Richmond Parkway, along a  
47 curve to the right having a radius of 7,850.00 feet, central angle of 09  
48 degrees 46 minutes 41 seconds, 1,339.68 feet to a point of compound  
49 curvature; thence continuing southerly and along the westerly margin of  
50 the Richmond Parkway on a curve to the right having a radius of 3,982.81  
51 feet, central angle of 02 degrees 31 minutes 46 seconds, 175.84 feet  
52 (chord bearing = South 16 degrees 03 minutes 52 seconds West, 175.82  
53 feet) to a point, said point being the northeast corner of lands now or  
54 formerly of the Greater New York Councils, Boy Scouts of America, by  
55 deed dated February 25, 1949 and recorded in Liber 1067 of Deeds at page  
56 502 in the Richmond County Clerk's Office on March 2, 1949; thence

1 northwesterly, southwesterly and northwesterly along the lands now or  
2 formerly of the Greater New York Councils, Boy Scouts of America, the  
3 following four (4) courses and distances:

4 1) North 54 degrees 13 minutes 34 seconds West, 14.48 feet to a point;

5 2) North 56 degrees 39 minutes 35 seconds West, 705.86 feet to a  
6 point;

7 3) South 27 degrees 01 minutes 06 seconds West, 253.50 feet to a  
8 point;

9 4) North 45 degrees 38 minutes 00 seconds West, 499.06 feet to a  
10 point; said point being on the southeasterly terminus of Yates Avenue, a  
11 paper street; thence northeasterly along the southeasterly terminus of  
12 the said Yates Avenue, North 25 degrees 37 minutes 40 seconds East,  
13 31.05 feet to a point on the northeasterly margin of Yates Avenue;  
14 thence northwesterly along the northeasterly margin of Yates Avenue,  
15 North 63 degrees 44 minutes 59 seconds West, 922.22 feet to the point  
16 and place of beginning.

17 RESERVING to the Grantor, in fee, an 18-acre parcel of land lying  
18 within the bounds of the above-described premises over which the Grantor  
19 will grant a conservation easement to the Grantee by instrument of even  
20 date and intended to be recorded prior to or simultaneously with this  
21 deed and which parcel of land is more particularly described as follows:

22 BEGINNING at a point on the southeasterly margin of Manor Road,  
23 distant 611.09 feet northeasterly from its intersection with the  
24 northeasterly margin of Yates Avenue, a paper street; thence continuing  
25 along said margin of Manor Road generally northeasterly, northerly and  
26 northeasterly the following four (4) courses and distances;

27 1) North 24 degrees 25 minutes 39 seconds East, 665.52 feet to a  
28 point;

29 2) North 49 degrees 23 minutes 26 seconds East, 109.29 feet to a  
30 point;

31 3) North 03 degrees 23 minutes 00 seconds West, 30.38 feet to a point;

32 4) North 49 degrees 35 minutes 00 seconds East, 176.97 feet to a  
33 point; thence through and along said lands, the following eleven (11)  
34 courses and distances:

35 1) Due East, 252.70 feet to a point;

36 2) South 11 degrees 08 minutes 27 seconds East, 384.67 feet to a  
37 point;

38 3) South 42 degrees 34 minutes 40 seconds East, 433.41 feet to a  
39 point;

40 4) South 55 degrees 19 minutes 40 seconds East, 497.57 feet to a  
41 point;

42 5) South 34 degrees 40 minutes 20 seconds West, 180.00 feet to a  
43 point;

44 6) North 55 degrees 19 minutes 40 seconds West, 160.00 feet to a  
45 point;

46 7) South 34 degrees 40 minutes 20 seconds West, 252.03 feet to a  
47 point;

48 8) North 56 degrees 56 minutes 18 seconds West, 640.82 feet to a  
49 point;

50 9) North 52 degrees 29 minutes 04 seconds West, 442.04 feet to a  
51 point;

52 10) South 15 degrees 06 minutes 16 seconds West, 252.19 feet to a  
53 point;

54 11) North 76 degrees 15 minutes 00 seconds West, 195.45 feet to a  
55 point and place of beginning; containing 18.00 acres of land, more or  
56 less.

1 ALSO RESERVING to the Grantor the right to occupy and use for camp  
2 purposes the premises hereby conveyed, in fee, for the term of 99 years  
3 from October 1, 1990. The conditions of such use and occupancy, which  
4 shall be for a ten-week period in each year during said terms and more  
5 fully set forth in an agreement of even date between the Grantor and the  
6 Grantee and intended to be recorded prior to or simultaneously with this  
7 deed.

8 It is intended by this deed to convey a parcel of land containing  
9 56.785 acres more or less, in fee, subject to the above-described term  
10 estate reserved to the Grantor.

11 Bearings are referenced to the system as established by the United  
12 States Coast Guard and Geodetic Survey for the Borough of Richmond.

13 TOGETHER WITH all right, title, and interest of the Grantor in and to  
14 all ponds, streams, streets, roads, and highways lying within, travers-  
15 ing, and abutting the premises hereby conveyed.

16 Subject to the rights, if any, of the City of New York in and to that  
17 portion of the above-described premise lying within the beds of the  
18 following streets as the same are shown on Re-Subdivision of Map of  
19 Ocean Terrace filed in the Richmond County Clerk's office as Map #1438:  
20 Foster, Browning, Morse, Bogert, Millard & Pitt Avenues, Peru Street  
21 (formerly Gibson Avenue) and Hays Place (formerly Cromwell Avenue).

22 Also, Subject to the rights, if any, of the City of New York in and to  
23 that portion of the above-described premises lying within the beds of  
24 Siersema, Kesselman & Mayer Avenues as the same are shown on Map of  
25 Lakewood Manor dated August, 1925 and filed in the Richmond County  
26 Clerk's Office as Map #1581.

27 BEING the same premises, or portions thereof, conveyed to the Feder-  
28 ation of Jewish Philanthropies of New York by the following deeds  
29 recorded in the Richmond County Clerk's Office:

5 16) Deed from Greater New York Councils, Boy Scouts of America, dated  
6 July 14, 1960, recorded August 1, 1960 in Liber 1501 Cp 205.

7 TOGETHER WITH the appurtenances and all the estate and rights of the  
8 Grantor in and to said premises.

9 § 3. The commissioner shall agree to amend the deed by replacing the  
10 words "for the term of 99 years from October 1, 1990" appearing in the  
11 sentence beginning "ALSO RESERVING" with the words "for the term of  
12 years until September 30, 2122".

13 § 4. The commissioner shall agree to amend the agreement as follows:

14 1. In the second WHEREAS clause of the agreement, replace the words  
15 "for a period of 99 years" with the words "until September 30, 2122".

16 2. In the first sentence of section one of the agreement, replace the  
17 words "for a period expiring 99 years from the first day of October  
18 first following the recording of the deed conveying the Property to The  
19 People of the State of New York," with the words "for a period expiring  
20 September 30, 2122,".

21 3. At the end of section seventeen of the agreement, add the words  
22 "The Commissioner shall have to power to waive in writing any limita-  
23 tion, restriction or requirement contained in this Agreement."

24 § 5. This act shall take effect immediately; provided, however, that  
25 instruments amending the deed and the agreement as provided for in this  
26 act shall be prepared and executed by UJA and delivered to the commis-  
27 sioner within thirty days after this act takes effect and shall be  
28 executed by the commissioner and returned to UJA within thirty days  
29 thereafter, whereupon UJA shall cause such instruments to be recorded in  
30 the Richmond county clerk's office and shall deliver copies of the  
31 recorded instruments to the commissioner.
