Introduced by M. of A. CONRAD -- read once and referred to the Committee on Corporations, Authorities and Commissions

AN ACT to amend chapter 560 of the laws of 1998 amending the not-forprofit corporation law and other laws, relating to combinations of cemetery corporations and funeral entities, and the sale of monuments and memorials, in relation to the application of provisions of the not-for-profit corporation law and other laws to certain crematoriums located in the town of Tonawanda; and to repeal certain provisions of such chapter relating thereto

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The legislature finds and declares that the public health, 1 2 safety and welfare of the residents of the state of New York in and 3 around the town of Tonawanda is a matter of substantial state concern. 4 The legislature also finds and declares that the state has a vital 5 interest in the oversight of places of final disposition as well as the 6 protection of its citizens directly affected by such places. The residents of the state in the town of Tonawanda have been subjected to 7 8 heightened levels of air pollution due to aging and failing equipment at 9 certain crematoriums. A crematorium located close to residential areas 10 with a consistently poor record of complying with clean air laws, creating a hazardous environment for the citizens of the state is to a 11 substantial degree a matter of state concern. Therefore, the provisions 12 hereinafter prescribed are enacted and their necessity in the public 13 interest is hereby declared as a matter of legislative determination. 14

15 § 2. Subdivision 1 of section 14 of chapter 560 of the laws of 1998 16 amending the not-for-profit corporation law and other laws, relating to 17 combinations of cemetery corporations and funeral entities, and the sale 18 of monuments and memorials, as amended by chapter 513 of the laws of 19 2021, is amended to read as follows:

2	by a funeral entity in the town of Tonawanda that has been subject to a

4	the provisions of this act shall not apply to the operation of any
5	crematory or crematorium, or act of cremation performed by a funeral
б	entity after the effective date of this act, if the funeral entity:
7	a. operated such crematory or crematorium, or performed cremations
8	prior to January 1, 1998; or
9	b. filed an application with the cemetery board for the operation of a
10	crematory or crematorium prior to January 1, 1998.
11	§ 3. Subdivision 2 of section 14 of chapter 560 of the laws of 1998

amending the not-for-profit corporation law and other laws, relating to combinations of cemetery corporations and funeral entities, and the sale of monuments and memorials, is REPEALED.

15 § 4. This act shall take effect on the one hundred eightieth day after 16 it shall have become a law.
