AN ACT to amend chapter 584 of the laws of 1996 relating to incorporation of the Wheatfield Volunteer Firefighter's Benevolent Association and providing for its powers and duties, in relation to its purpose and the use of foreign fire insurance premium taxes

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 3 of chapter 584 of the laws of 1996 relating to 2 incorporation of the Wheatfield Volunteer Firefighter's Benevolent Asso-3 ciation and providing for its powers and duties, is amended to read as 4 follows:

5 § 3. Purposes. The purposes of such corporation shall be the mainteб nance of suitable headquarters for, and the promotion of fraternal 7 intercourse among the members of such corporation $[\tau]_i$ the relief, aid and assistance of volunteer firefighters and their families who are 8 injured, disabled or indigent [, and the promotion of]; to promote and 9 **<u>safequard</u>** the welfare of the volunteer [fire service] <u>members of the</u> 10 11 corporation, and their families; to provide for the health and safety of 12 the volunteer members of the corporation; and to enhance the morale of 13 the volunteer members of the corporation by providing social and recre-14 ational activities for the volunteer members of the corporation and the promotion of the volunteer fire service within the territory protected 15 by such fire department of the Wheatfield Volunteer Firefighter's Benev-16 17 olent Association.

18 § 2. Section 7 of chapter 584 of the laws of 1996 relating to incorpo-19 ration of the Wheatfield Volunteer Firefighter's Benevolent Association 20 and providing for its powers and duties, is amended to read as follows:

21 § 7. Precept for payment of foreign fire insurance premium taxes. Such 22 corporation shall collect and there shall be paid to it all taxes

imposed by section 9104 of the insurance law for fire department use and 1 2 benefit, upon premiums for insurance against loss or damage by fire covering property situated in the territory in which the Adams Fire 3 Company Inc., St. Johnsburg Fire Company Inc., and Frontier Fire Company 4 5 Inc., in the town of Wheatfield, county of Niagara, are or may be obli-6 gated to render fire protection. The officers of said corporation desig-7 nated by its by-laws to collect and receive the aforesaid tax shall have 8 all the powers and be subject to all the provisions of the insurance 9 law, relating to treasurers of the fire companies. Such corporation 10 shall also be entitled to receive a share of the tax imposed by section 11 9105 of the insurance law, based upon the business written in the terri-12 tory with respect to which it is entitled to collect and receive the tax under section 9104 of the insurance law. Such taxes shall only be used 13 14 [for the care and relief of disabled or indigent volunteer and exempt 15 volunteer firefighters and their families] by the corporation in furtherance of its purposes as set forth in section three of this act. 16

17 § 3. This act shall take effect immediately and shall apply to taxes 18 due on premiums received on and after January 1, 2024.
