AN ACT to amend the public health law, in relation to enacting "Matthew's law"

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. Short title. This act shall be known and may be cited as 2 "Matthew's law".
- \S 2. The public health law is amended by adding a new section 3309-c 4 to read as follows:
- 5 § 3309-c. Dispensing of drug adulterant testing supplies. 1. As used 6 in this section:

- (a) "Drug adulterant testing supplies" means any drug testing product that is used to determine whether a controlled substance contains fentanyl, a fentanyl analog, or Xylazine.
- 10 (b) "Health care professional" means a person licensed, registered or 11 authorized pursuant to title eight of the education law to prescribe 12 prescription drugs.
- 13 <u>(c) "Pharmacist" means a person licensed or authorized to practice</u> 14 <u>pharmacy pursuant to article one hundred thirty-seven of the education</u> 15 <u>law.</u>
- 2. A health care professional or pharmacist is authorized to dispense drug adulterant testing supplies to any person. Any drug adulterant

 19 <u>licensed pharmacy, hospital, clinic, or other health care facility or at</u>
- the medical office of a health care professional and in a manner that

limits access to the drug adulterant testing supplies to health care 2 professionals or pharmacists employed at the pharmacy, hospital, clinic, or other health care facility or medical office and any persons designated by the health care professional or pharmacist. Drug adulterant 5 testing supplies dispensed at a retail store containing a pharmacy under this section shall be dispensed only from the pharmacy department of the retail store. No quantity of drug adulterant testing supplies greater than necessary to conduct five assays of substances suspected of containing adulterants shall be dispensed in any single transaction.

- 3. The commissioner shall promulgate all rules and regulations necessary for the implementation of this section.
- § 3. This act shall take effect on the thirtieth day after it shall 12 13 have become a law. Effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of 14 15 this act on its effective date are authorized to be made and completed 16 on or before such effective date.
