AN ACT to amend the tax law, in relation to establishing a tax on direct broadcast satellite services and video streaming services; and to amend the state finance law, in relation to establishing the community media reinvestment fund

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. Short title. This act shall be known and may be cited as
2	the "community media reinvestment act".
3	§ 2. The tax law is amended by adding a new article 15 to read as
4	follows:

10	<u>§ 330. Definitions. For the purposes of this article, the following</u>
11	terms shall have the following meanings:
12	1. "municipality" means any village, town, city, or county not wholly
13	contained within a city in the state of New York;
14	2. "person" means an individual, partnership, limited liability compa-
15	ny, trust or association, with or without transferable shares, joint-
16	stock company, corporation, society, club, organization, institution,
17	<u>estate, receiver, trustee, assignee or referee and any other person</u>
18	acting in a fiduciary or representative capacity, whether appointed by a
19	court or otherwise, and any combination of individuals acting as a unit.
20	The term "person", unless expressly provided otherwise, does not
21	include:

13	al public who receives direct broadcast satellite service or video

	<u>5. "direct broadcast satellite service" means the distribution or</u>

18	broadcasting by satellite of video programming or services directly to
19	receiving equipment located at an end user subscriber's or an end user
20	customer's premises, including, but not limited to, the provision of
21	premium channels, the provision of music or other audio services or
22	channels, and any other service received in connection with the
23	provision of direct broadcast satellite service;
24	6. "direct broadcast satellite service provider" means a person who
25	transmits, broadcasts or otherwise provides direct broadcast satellite
26	service to subscribers or customers in the state;
27	7. "video streaming service" means the distribution or broadcasting of
28	video programming displayed by the viewer for a fee on a subscription
29	basis. The term video streaming service, unless expressly provided
30	otherwise, does not include cable service as defined by 47 U.S.C. §
31	<u>522(6);</u>
32	8. "video streaming service provider" means a person who transmits,
33	broadcasts or otherwise provides video streaming service to subscribers
34	or customers in the state;
35	9. "video programming" means programming provided by, or comparable to
36	programming provided by, a television broadcast station including, but
37	not limited to, video programming provided by local networks, national
38	broadcast networks, cable television networks and all forms of pay-per-
39	view or on-demand video entertainment; and
40	10. "gross receipts" means all consideration of any kind or nature
41	received by a direct broadcast satellite service provider or video
42	streaming service provider, or an affiliate of such person, in
43	connection with the provision, delivery, or furnishing of direct broad-
44	cast satellite service or video streaming service to subscribers or
45	customers within the state, determined according to the hierarchy
46	described in section three hundred thirty-one of this article. "Gross
47	receipts" shall not include:
48	(a) revenue not actually received, regardless of whether it is billed,
49	including, but not limited to, bad debts;
50	(b) revenue received by an affiliate or other person in exchange for
51 52	supplying goods and services to an affiliated direct broadcast satellite
52 52	service provider or affiliated video streaming service provider;

1	(e) revenue from any service that is subject to tax under article

3	(f) revenue from the sale of capital assets or surplus equipment not
4	used by the purchaser to receive direct broadcast satellite service or
5	video streaming service from the direct broadcast satellite service
6	provider or video streaming service provider;
7	(g) reimbursements made by programmers to the direct broadcast satel-
8	lite service provider or video streaming service provider for marketing
9	costs incurred by such service provider for the introduction of new
10	programming;
11	(h) late payment fees collected from subscribers or customers; or
12	(i) charges, other than charges for direct broadcast satellite
13	services or video streaming services, that are aggregated or bundled
14	with direct broadcast satellite services or video streaming services on
15	a subscriber's or customer's bill, if the direct broadcast satellite
16	service provider or video streaming service provider can reasonably and
17	separately identify the charges in its books and records kept in the
18	regular course of business.
19	§ 331. Imposition and collection of an assessment on direct broadcast
20	satellite services and video streaming services. 1. There is hereby
21	imposed an excise tax on the provision, delivery, or furnishing of
22	direct broadcast satellite services or video streaming services by
23	direct broadcast satellite service providers or video streaming service
24	providers to subscribers or customers in the state.
25	2.(a) Direct broadcast satellite service providers and video streaming
26	service providers shall pay an assessment equal to five percent of such
27	provider's gross receipts derived in or from the provision, delivery, or
28	furnishing of direct broadcast satellite service or video streaming
29	service to subscribers or customers in the state.
30	(b) Gross receipts derived in or from the provision, delivery, or
31	furnishing of direct broadcast satellite service or video streaming
32	service by direct broadcast satellite service providers or video stream-
33	ing service providers to subscribers or customers in the state shall be
34	determined by the hierarchy of sourcing methods set forth in paragraph
35	(c) of this subdivision. The direct broadcast satellite service provider
36	or video streaming service provider shall exercise due diligence under
37	each method described in paragraph (c) of this subdivision before
38	rejecting it and proceeding to the next method in the hierarchy, and
39	shall base its determination on information known to it or information
40	that would be known to it upon reasonable inquiry.
41	(c) Hierarchy of sourcing methods:
42	(i) the customer's primary use location of the direct broadcast satel-
43	<u>lite service or video streaming service; and</u>
44	(ii) the customer's billing address.
45	3. The tax authorized in this section shall be for each year, or part
46	of each year, that such direct broadcast satellite service provider or
47	video streaming service provider is engaged in the sale of direct broad-
48	cast satellite or video streaming services to subscribers or customers
49	in the state.
50	4. (a) Every direct broadcast satellite service provider and/or video
51	streaming service provider subject to tax under this section shall (i)
52	file, on or before April fifteenth of each year, for taxable years
53	beginning on or after January first, two thousand twenty-four, a return
54	for the year ended on the preceding December thirty-first, and (ii) pay
55	the tax due, which return shall state the gross receipts for the period

56 covered by each such return.

(b) Returns shall be filed with the commissioner on a form to be 1 furnished by the commissioner for such purpose and shall contain such 2 3 other data, information or matter as the commissioner may require to be 4 included therein. 5 (c) Notwithstanding paragraphs (a) and (b) of this subdivision, the 6 commissioner may require any direct broadcast satellite service provider 7 and/or video streaming service provider to file an annual return, which 8 shall contain any data specified by the commissioner, regardless of 9 whether such provider is subject to tax under this section. 10 5. (a) A direct broadcast satellite service provider or video stream-11 ing service provider who fails to file a return or to pay any tax within 12 thirty days of the time required pursuant to this article (determined with regard to any extension of time for filing or paying) shall be 13 14 subject to a penalty of ten percent of the amount of the tax determined 15 to be due, plus five percent of such amount for each subsequent month or fraction thereof during which such failure continues, not to exceed 16 17 thirty percent in the aggregate. (b) In the event of an underpayment of the tax owed, the commissioner 18 shall set the underpayment rate of interest to be paid, but the under-19 20 payment rate shall not be less than seven and one-half percent per 21 annum, compounded daily. If no such rate of interest is set, such under-22 payment rate shall be deemed to be set at seven and one-half percent per annum, compounded daily. Any such rate set by the commissioner shall 23 apply to taxes, or any portion thereof, which remain or become due or 24 25 underpaid on or after the date on which such rates become effective and shall apply only with respect to interest computed or computable for 26 27 periods or portions of periods occurring in the period during which such 28 rates are in effect. 6. Every direct broadcast satellite service provider and/or video 29 30 streaming service provider subject to tax under this section shall keep 31 such records of its business and in such form as the commissioner may 32 require, and such records shall be preserved for a period of three 33 years, except that the commissioner may consent to their destruction 34 within that period or may require that they be kept longer. 35 3. The state finance law is amended by adding a new section 99-m to 3 36 read as follows: 37 § 99-m. Community media reinvestment fund. 1. There is hereby established in the joint custody of the comptroller and the commissioner of 38 39 taxation and finance a special fund to be known as the "community media reinvestment fund". 40 41 2.(a) All monies received by the comptroller or the commissioner of taxation and finance for the purpose of this fund shall be deposited 42 43 therein. No monies may be transferred from this account to any other 44 account except by authority of the commissioner of taxation and finance. 45 (b) Such fund shall consist of the revenue collected pursuant to arti-46 cle fifteen of the tax law and any other revenues collected by or appro-47 priated to the fund pursuant to any other law. 48 3.(a) The commissioner of taxation and finance is authorized to utilize the monies in the community media reinvestment fund, for 49 distribution to the state, municipalities, and community media organiza-50 tions in proportions as provided in paragraph (b) of this subdivision, 51 52 provided however, that the commissioner may retain up to ten percent of the monies in the fund annually for operational expenditures. 53 54 (b) The commissioner of taxation and finance shall annually distribute, with no remainder left, all monies then held in the community media 55

56 <u>reinvestment fund according to the following formula:</u>

1	(i) one-fifth of the monies in the fund, less the monies retained by
2	the commissioner for operational expenditures, shall be distributed to
3	the state general fund;
4	(ii) two-fifths of the monies in the fund shall be distributed direct-
5	ly to municipalities in the state, and further allocated proportionally
б	based upon the population of such municipalities;
7	(iii) two-fifths of the monies in the fund shall be distributed
8	directly to identified community media organizations in the state, or,
9	if no community media organization has been identified in a given muni-
10	cipality, to the organization or organizations serving that municipality
11	identified by the New York state council on the arts to receive distrib-
12	utions from the fund, and further allocated proportionally based on the
13	population of the municipality or municipalities served by each such
14	identified organization.
15	4. The commissioner of taxation and finance shall promulgate regu-
16	lations by December thirty-first, two thousand twenty-three to establish
17	procedures for identifying, on an annual basis, (a) community media
18	organizations eligible to receive monies distributed pursuant to subpar-
19	agraph (iii) of paragraph (b) of subdivision three of this section; and
20	(b) in the event that no community media organization has been identi-
21	fied in a given municipality, the organizations serving that munici-
22	pality identified by the New York state council on the arts, eligible to
23	receive monies distributed pursuant to subparagraph (iii) of paragraph
24	(b) of subdivision three of this section. Notwithstanding any other
25	provisions to the contrary in the New York state administrative proce-
26	dure act (SAPA), such rules and regulations may be adopted on an emer-
27	gency basis if necessary to meet such December thirty-first, two thou-
28	sand twenty-three deadline.
29	5. All payments of monies from the fund shall be made on the audit and
30	warrant of the comptroller.

31 § 4. This act shall take effect immediately and apply to taxable years 32 beginning on and after January 1, 2024.
