AN ACT to amend the limited liability company law and the partnership law, in relation to the definition of office and the content of notices published in newspapers

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision (s) of section 102 of the limited liability 1 company law is amended to read as follows:

- (s) "Office of the limited liability company" means the office of the limited liability company, the location of which is stated in the articles of organization of a domestic limited liability company, or in the application for authority of a foreign limited liability company.
