AN ACT to amend the administrative code of the city of New York and chapter 53 of the laws of 2012, enacting the aid to localities budget, in relation to substance abuse prevention personnel in New York city schools

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The administrative code of the city of New York is amended
2 by adding a new section 12-141 to read as follows:

3 § 12-141 Substance abuse prevention and intervention personnel. The
4 New York city department of education shall provide on a full-time basis
5 at least one substance abuse prevention and intervention specialist at
6 each public school in the city of New York. For the purposes of this
7 section, a substance abuse prevention and intervention specialist is a
8 New York city department of education employee that has received
9 substance abuse training through the New York state office of addiction
10 services and supports.

11 § 2. Section 1 of chapter 53 of the laws of 2012, enacting the aid to
12 localities budget, is amended by repealing the items hereinbelow set
13 forth in brackets and by adding to such section the other items under-
14 scored in this section.
