AN ACT to establish a task force to identify evidence-based and evidence informed solutions to reduce children's exposure to adverse childhood experience

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. A task force on adverse childhood experiences (ACEs) is hereby established to examine, evaluate, accept public comment and make recommendations concerning the impact of ACEs and preventive and trauma-informed policy and practices.

- 5 \S 2. The task force shall consist of 10 members to be appointed as 6 follows:
 - a. One member appointed by the department of health;
 - b. One member appointed by the office of children and family services;
- 9 c. One member appointed by the state education department;
- 10 d. One member appointed by the department of criminal justice 11 services;
- 12 e. One member appointed by the temporary president of the senate;
- 13 f. One member appointed by the speaker of the assembly; and
- g. Four members appointed by the governor.

- 15 § 3. The members of the task force shall each have experience in or 16 represent the following areas: juvenile justice, social services, public 17 health, childhood development, minority and ethnic groups, education 18 prekindergarten through grade 12. The governor shall designate the chair 19 of the task force which shall be filled in the manner provided for 20 original appointments.
- § 4. The members of the task force shall receive no compensation for their services, but shall be allowed their actual and necessary expenses incurred in the performance of their duties pursuant to this act.

- § 5. The task force shall perform the following duties:
- (1) Engage social services, office of children and family services, education, health, and criminal justice systems in creation of traumainformed policy and practices in each of these systems to prevent adverse childhood experiences from occurring and support the health and well-being of all families.
- (2) Identify social determinants of health and well-being and recommend solutions to eliminate racial and ethnic disparities in the state in relation to the occurrence of ACEs.
- § 6. To the maximum extent feasible, the task force shall be entitled to request and receive, and shall utilize and be provided with such facilities, resources and data of any department, division, board, bureau, commission, district or agency of the state or any political 13 14 subdivision thereof as it may reasonably request to properly carry out its powers and duties pursuant to this act.
- 16 § 7. The task force shall submit, within 2 years of the effective date 17 of this act, a report of its findings, conclusions and recommendations to the governor, temporary president of the senate, speaker of the 18 assembly, minority leader of the senate, minority leader of the assem-19 20 bly, chair of senate education committee, chair of assembly education 21 committee, chair of senate health committee, chair of assembly health 22 committee, chair of senate social services committee, chair of assembly 23 social services committee, chair of senate children and families commit-24 tee and chair of assembly children and families committee.
 - § 8. This act shall take effect immediately.
