AN ACT to amend the executive law, in relation to adding North Chuctanunda creek to the definition of inland waterways

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph (c) of subdivision 4 of section 911 of the execu-
2 tive law, as separately amended by chapters 342 and 352 of the laws of
3 2022, is amended to read as follows:
4 (c) the state's major creeks comprised of the 18 Mile Creek located in
5 Erie county, Chittenango Creek, Bash Bish and Kinderhook Creek located
6 in Columbia county, Kinderhook Creek located in Rensselaer county, Bash-
7 er Kill, Bushkill, Cattaraugus, Cayadutta, North Chuctanunda, Cincinna-
8 ti, East Kill, Esopus (including upper and lower branches), Ferguson,
9 Fish (including east and west branches), Gooseberry, Great Valley,
10 Kenyetto, Little Sandy, Moyer, Mud Creek located in Oneida county,
11 Ninemile Creek, Onondaga, Oriskany, Peekskill Hollow, Reall, Roeliff
12 Jansen Kill, Rondout, Sandy, Sauquoit, Schoharie, Shawangunk Kill, Six
13 Mile Creek, South Sandy, Oatka, Tonawanda, West Kill, Scajaquada,
14 Wappinger, Webatuck, Wassaic, Willsey in the village of Wurtsboro, Wood
15 Creek located in Herkimer county, Wood Creek located in Oneida county,
16 Black Creek located in Monroe county, Black Creek located in Genesee and
17 Wyoming counties, Ellicott Creek located in Erie county, Wynantskill,
18 Claverack, Taghkanic, Agawamuck, Wyomanock, and Ley Creek and Butternut
19 Creek located in Onondaga county, Nanticoke and Sawkill (in Ulster coun-
20 ty), Saw Kill and Fall Kill located in Dutchess county, Otter Kill Creek
21 located in Orange county, Black Meadow Creek located in Orange county;
22 § 2. This act shall take effect immediately.
