Introduced by Sen. SALAZAR -- read twice and ordered printed, and when printed to be committed to the Committee on Local Government

AN ACT to amend chapter 548 of the laws of 2022 relating to authorizing the city of New York to discontinue the use as parkland a portion of real property in the borough of Brooklyn and to transfer such lands to the metropolitan transportation authority, to enable the New York city transit authority to construct in such areas new permanent at-grade station improvements and pedestrian bridges, in relation to making technical amendments thereto

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Sections 3, 5 and 6 of chapter 548 of the laws of 2022  
2 relating to authorizing the city of New York to discontinue the use as  
3 parkland a portion of real property in the borough of Brooklyn and to  
4 transfer such lands to the metropolitan transportation authority, to  
5 enable the New York city transit authority to construct in such areas  
6 new permanent at-grade station improvements and pedestrian bridges, are  
7 amended to read as follows:

8 § 3. The lands hereby authorized by section one of this act to be  
9 discontinued permanently as parkland and transferred to the metropolitan  
10 transportation authority are located in the county of Kings, city and  
11 state of New York in a park known as the Callahan-Kelly Park, and are  
12 bounded and described as follows:

13 Area A: acquisition of property rights on Tax Lot 1 in Block 1546,  
14 Borough of Brooklyn:

15 Beginning at the Point of Commencement, (N=186378.8532,  
16 E=1009899.0749) (NAD83 / NAVD88) at the corner formed by the inter-  
17 section of the northerly line of Fulton Street, an eighty feet width  
18 right of way, and the easterly line of Eastern Parkway, a one-hundred-  
19 and ten-foot width right of way, running thence,

5 of Beginning, thence,

6 1) On a line in a general westerly direction having an interior angle  
7 of  $89^{\circ}57'01''$  with the previous course 55.94' to a point, thence,

8 2) On a line in a general Northerly direction having an interior angle  
9 of  $79^{\circ}17'17''$  with the previous course 65.85' to a point, thence,

10 3) On a line in a general easterly direction having an interior angle

52 2) On a line in a general northerly direction having an interior angle  
53 of  $90^{\circ}00'00''$  with the previous course 18.75' to a point, thence,

54 3) On a line in a general easterly direction having an interior angle

34 9) On a line in a general southerly direction having an interior angle  
35 of 243°05'37" with the previous course 9.83' to a point, thence,

36 10) On a line in a general southerly direction having an interior  
37 angle of 206°39'47" with the previous course 10.30' to a point, thence,

38 11) On a line in a general easterly direction having an interior angle  
39 of 74°49'13" with the previous course 1.53' to a point, thence,

40 12) On a line in a general southerly direction having an interior  
41 angle of 285°06'22" with the previous course 40.81' to a point, thence,

42 13) On a line in a general easterly direction having an interior angle  
43 of 70°44'54" with the previous course 45.92, to a point along the  
44 westerly sideline of Van Sinderen Avenue, a one-hundred feet width right  
45 of way, thence,

46 14) Along the westerly sideline of Van Sinderen Avenue in a general  
47 northerly direction having an interior angle of 82°50'36" with the  
48 previous course 73.34' to the point of curvature along the same westerly  
49 sideline of Van Sinderen, now opened at one-hundred feet wide, thence,

50 15) Along the arc, having a curve to the left, a radius of 70 feet,  
51 delta of 89°46'03", arc distance of 109.69' feet to the point of tangen-  
52 cy along the southerly sideline of Truxton Street, a seventy feet width  
53 right of way, thence,

54 16) Along the southerly sideline of Truxton Street from the point of  
55 tangency in a general [~~easterly~~] westerly direction 13.42' to the Point  
56 of Beginning.

1 Said parcel containing 8,564 square feet (0.20 acres) of land more or  
2 less.

3 § 6. The lands hereby authorized to be dedicated as parklands by the  
4 city of New York on the terms set forth in section two of this act are  
5 located in the county of Kings, city and state of New York and bounded  
6 and described as follows:

7 Portion of Sackman Street abutting Tax Lot 1 in Block 1546, Borough of  
8 Brooklyn:

9 Beginning at the Point of Commencement, (N=186378.8532,  
10 E=1009899.0749) (NAD83) at the corner formed by the intersection of the  
11 northerly line of Fulton Street, an eighty feet width right of way, and  
12 the north-easterly line of Eastern Parkway, a one-hundred- and ten-feet  
13 width right of way, running thence,

14 Easterly along the said northerly sideline of Fulton Street 466.90' to  
15 the Point of Beginning on the same northerly sideline of Fulton Street,  
16 and the easterly sideline of Sackman Street, thence,

17 1) Along the easterly sideline of Sackman Street in a general norther-  
18 ly direction having an interior angle of 74°27'51" with the previous  
19 course [~~124.23'~~ 146.23' to a point along the southerly sideline of  
20 Truxton Street a 70' width right of way, thence,

21 2) Along the southerly sideline of Truxton Street in a general wester-  
22 ly direction having an interior angle of 92°50'53" with the previous  
23 course 80.10' to a point on the same southerly sideline of Truxton  
24 Street and the westerly sideline of Sackman street, thence,

25 3) Along the westerly sideline of Sackman Street in a general souther-

27 course 127.97' to a point along the westerly sideline of Sackman Street  
28 and the northerly sideline of Fulton Street, thence,

31 course 83.03' to the Point of Beginning.

32 Said parcel containing 10,968 square feet (0.25 acres) of land more or  
33 less.

34 § 2. This act shall take effect immediately.
