AN ACT to amend the banking law, in relation to attorney trust accounts

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The banking law is amended by adding a new section 9-e to 2 read as follows:

§ 9-e. Attorney trust accounts. Notwithstanding any other provision of 4 law or rule or regulation to the contrary, no bank or trust company 5 regulated by the state of New York shall charge a service fee or require 6 a minimum balance on an attorney trust account, provided that no more 7 than fifteen debit or credit transactions per month are made in connection with such account and provided, further, that such attorney trust account is non-interest bearing or is an IOLA (interest on lawyer 9 10 accounts) account. For the purposes of this section, an attorney trust 11 account shall mean a special banking or checking account required by law 12 or a rule of court for the deposit of funds belonging to law clients or other persons in the practice of law. 13

14 § 2. This act shall take effect on the thirtieth day after it shall 15 have become a law.
