AN ACT to amend the alcoholic beverage control law, in relation to exempting certain parcel of land from licensing restrictions prohibiting manufacturers, wholesalers and retailers of alcoholic beverages from sharing an interest in a licensed premises

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph (a) of subdivision 1 of section 101 of the alco-
2 holic beverage control law is amended by adding a new subparagraph
3 (xvii) to read as follows:

4 (xvii) Any or parcel of land, situate, lying and being in the Borough
5 of Manhattan, City, County and State of New York, bounded and described
6 as follows; beginning at a point on the southerly side of 72nd Street
7 distant 179 feet easterly from the southerly corner of Amsterdam Avenue
8 and 72nd Street; running thence southerly and parallel with the easterly
9 side of Amsterdam Avenue 102 feet 2 inches to the center line of the
10 block; thence easterly and parallel with the southerly side of 72nd
11 Street 21 feet; thence northerly and parallel with the easterly side of
12 Amsterdam Avenue and part of the distance through a party wall 102 feet
13 2 inches to the southerly side of 72nd Street; thence westerly along
14 the southerly side of 72nd Street 21 feet to the point or place of
15 beginning.

16 § 2. Section 105 of the alcoholic beverage control law is amended by
17 adding a new subdivision 24 to read as follows:

18 24. The provisions of subdivision sixteen or seventeen of this section
19 shall not apply to any interest in a wholesale premise outside the
20 United States, held by any business or entity located on any or parcel
21 of land, situate, lying and being in the Borough of Manhattan, City,
22 County and State of New York, bounded and described as follows:

1 Beginning at a point on the southerly side of 72nd Street distant 179
2 feet easterly from the southerly corner of Amsterdam Avenue and 72nd
3 Street; running thence southerly and parallel with the easterly side of
4 Amsterdam Avenue 102 feet 2 inches to the center line of the block;
5 thence easterly and parallel with the southerly side of 72nd Street 21
6 feet; thence northerly and parallel with the easterly side of Amsterdam
7 Avenue and part of the distance through a party wall 102 feet 2 inches
8 to the southerly side of 72nd Street; thence westerly along the souther-
9 ly side of 72nd Street 21 feet to the point or place of beginning.

10 § 3. This act shall take effect immediately.
