AN ACT to amend the highway law, in relation to designating certain portions of the state highway system as the "Between Cayuga and Seneca Lakes Wine Trail"

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The section heading of section 343-k of the highway law, as amended by chapter 227 of the laws of 2017, is amended and a new subdi-2 vision 3-a is added to read as follows:

Portions of the state highway system to be designated as the "Lake Erie Wine Country Trail", the "Canandaigua Wine Trail", the "Cayuga Wine Trail East", the "Cayuga Wine Trail West", the "Between Cayuga and Seneca Lakes Wine Trail", the "Seneca Lake Wine Trail East", the "Seneca Lake Wine Trail West", the "Keuka Lake Wine Trail", the "Shawangunk Wine Trail", the "Dutchess Wine Trail", the "North Fork Wine Trail", the "Hamptons Wine Trail", the "Long Island Wine Region", the "Niagara Wine Trail Ridge", the "Niagara Wine Trail Lake", the "Lake Ontario Wine 11 Trail", the "Adirondack Coast Wine Trail", the "St. Lawrence Wine Trail" and the "Upper Hudson Wine Trail".

3-a. All that portion of the state highway system constituting state 15 route 96 from its intersection with state route 13 in Ithaca to the intersection of state routes 96, 414 and 96A in Ovid, and then continu-16 ing on state route 96A to its intersection with state routes 5 & 20 in Geneva, and then continuing on state routes 5 & 20 to their intersection 19 with state route 14. Also, all that portion of the intersection of state 20 route 96A and state route 336 going east to the intersection of state 21 route 336 and state route 414 in Fayette. Also, all that portion of state route 96 from its intersection with state route 414 south of Romulus, continuing north through Waterloo and west to the intersection of 24 state routes 96 and 14 just south of interstate route I-90.
