AN ACT to amend the environmental conservation law, in relation to authorizing hunting big game by rifle in the county of Niagara; and providing for the repeal of such provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph a of subdivision 2 of section 11-0907 of the
2 environmental conservation law is amended by adding a new item (q) to
3 read as follows:

16 § 5. This act shall take effect immediately; provided, however, that:

17 a. the amendments to paragraph a of subdivision 2 of section 11-0907
18 of the environmental conservation law made by section one of this act
19 shall be subject to the expiration and reversion of such paragraph
20 pursuant to section 13 of chapter 600 of the laws of 1993, as amended;

21 b. the amendments to item (f) of paragraph a of subdivision 2 of
22 section 11-0907 of the environmental conservation law made by section
23 two of this act shall be subject to the expiration and reversion of such
24 item pursuant to paragraph d of section 5 of chapter 152 of the laws of
25 2020, as amended;

26 c. sections three and four of this act shall take effect upon the
27 expiration and reversion of paragraph a of subdivision 2 of section
28 11-0907 of the environmental conservation law, as provided in section 13
29 of chapter 600 of the laws of 1993, as amended; and

30 d. nothing contained in this act shall be construed so as to extend
31 the provisions of this act beyond October 1, 2026, when upon such date
32 this act shall expire and the provisions contained herein shall be
33 deemed repealed.
