AN ACT to amend chapter 54 of the laws of 2023, enacting the capital projects budget, in relation to safety and security projects at small businesses at risk of hate crimes

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 1 of chapter 54 of the laws of 2023, enacting the capital projects budget, is amended by repealing the items hereinbelow set forth in brackets and by adding to such section the other items underscored in this section.
