AN ACT to amend the social services law, in relation to prohibiting restrictions on the length of shelter stay

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

| 14 | (b) "Homeless youth" shall have the same meaning as set forth in |
| 15 | subdivision two of section five hundred thirty-two-a of the executive |
| 16 | law, and shall include homeless young adults. |
| 17 | (c) "Homeless young adult" shall have the same meaning as set forth in |
| 18 | subdivision nine of section five hundred thirty-two-a of the executive |

| 20 | (d) "Shelter" shall have the same meaning as "homeless project", as |
