AN ACT to amend the education law, in relation to requiring colleges and universities in the state to adopt a policy that requires students in programs for teaching, school administration, or counseling to have a curriculum that promotes diversity, equity and inclusion, and is multilingual for teaching immigrant-origin students

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 6206 of the education law is amended by adding a 2 new subdivision 23 to read as follows:

23. Notwithstanding any law, rule or regulation to the contrary, the 4 board of trustees shall update course curriculum as necessary to require senior colleges and community colleges within the city university include, within all education programs for teachers, administrators and counselors, the topics of local, state and national immigration policy and immigrant integration and how to best educate immigrant-origin students with different status in ways that promote diversity, equity and inclusion, and are multilingual.
