AN ACT to amend chapter 99 of the laws of 2014, amending the vehicle and traffic law, the general municipal law, and the public officers law relating to owner liability for failure of operator to comply with traffic-control indications in the city of New Rochelle, in relation to extending the provisions of such chapter

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 15 of chapter 99 of the laws of 2014, amending the  
2 vehicle and traffic law, the general municipal law, and the public offi-  
3 cers law relating to owner liability for failure of an operator to  
4 comply with traffic-control indications in the city of New Rochelle, the  
5 opening paragraph as amended by section 4 of part TT of chapter 58 of  
6 the laws of 2019, is amended to read as follows:

7 § 15. This act shall take effect on the thirtieth day after it shall  
8 have become a law; provided, however, that sections three, nine,  
9 twelve-b, thirteen and fourteen of this act shall expire and be deemed  
10 repealed December 1, [~~2024~~] 2029; and provided further that any rules  
11 necessary for the implementation of this act on its effective date shall  
12 be promulgated on or before such effective date, provided that:
