AN ACT to amend the public housing law and chapter 53 of the laws of 2024, enacting the aid to localities budget, in relation to authorizing funding that would affirmatively further fair housing including client intake and enforcement actions not directly tied to fair housing testing

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 2 of section 600 of the public housing law, as added by chapter 690 of the laws of 2021, is amended to read as follows:

2. The commissioner and all covered housing agencies shall administer all such programs and activities related to housing and community development in a manner that affirmatively furthers fair housing and shall cooperate with the commissioner to further such purpose. Any funding appropriated to any covered housing agency for fair housing testing shall include any services and expenses that further the purposes of this section including but not limited to client intake and enforcement actions not directly tied to fair housing testing.

§ 2. Section 1 of chapter 53 of the laws of 2024, enacting the aid to localities budget, is amended by repealing the items herein below set forth in brackets and by adding to such section the other items underscored in this section:
