AN ACT to amend the alcoholic beverage control law, in relation to
licensing restrictions for manufacturers and wholesalers of alcoholic
beverages on licensees who sell at retail; and providing for the
repeal of certain provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assem-
bly, do enact as follows:

1 Section 1. Subparagraph (xxii) of paragraph (a) of subdivision 13 of
2 section 106 of the alcoholic beverage control law, as added by chapter
3 527 of the laws of 2023, is amended and a new subparagraph (xxiii) is
4 added to read as follows:

5 (xxii) Parcel A

6 ALL that certain plot, piece or parcel of land with the buildings and
7 improvements thereon erected, situated, lying and being in the Town of
8 Wilmington, County of Essex and State of New York, being part of lot No.
9 32 of Mallory's Grant and more particularly described as follows:

10 BEGINNING at a point in the Wilmington-Lake Placid State Highway
11 (Route 86) said point being located 600 feet North Easterly from the
12 point where the division line between lots Nos. 31 and 32 of Mallory's
13 Grant intersects the center of said Highway and which point of beginning
14 is the most Easterly corner of a parcel of land conveyed by Bernard J.P.
15 Comiskey to Marjorie B. Wilkins by deed dated July 7, 1950 and recorded
16 in the Essex County Clerk's Office on July 10, 1950 in Book 279 of Deeds
17 at page 293, and from said point of beginning running thence in a
18 Northwesterly direction along the Northeasterly line of said parcel a
19 distance of 550 feet to the most Northerly corner thereof; thence South-
20 westerly along the Northeasterly line of said parcel (described as
21 parallel to the center of said highway) and continuing in the same
22 course along the Northwesterly line of a parcel of land conveyed by said
23 Comiskey to Walter N. Zywan and Marylyn V. Zywan a total distance on
24 this course of 600 feet to a point in the division line between said
25 lots Nos. 31 and 32; thence Northwesterly along said division line a
26 distance of 1985 feet more or less to the most Westerly corner of lot

1 No. 32; thence Northeasterly along the Westerly boundary of Mallory's
2 Grant a distance of 1696 feet more or less to the most Northerly corner
3 of lot No. 32; thence Southeasterly along the division line between lots
4 Nos. 32 and 33 a distance of 3280 feet more or less to a point in the
5 center of the aforesaid State Highway; thence Southwesterly along the
6 center thereof to the point or place of beginning.

7 Parcel B

8 ALL THAT TRACT, PART, PIECE OR PARCEL OF LAND, situate in Lots 33 and
9 34, Mallory's Grant, Town of Wilmington, County of Essex, State of New
10 York, being more particularly bounded and described as follows:

11 BEGINNING at a 3/4 inch iron pipe found in the southerly bounds of New
12 York State Highway Route 86, and at the most northerly corner of a
13 parcel of land belonging (N/F), to Betty Jane Smart, by virtue of a deed
14 recorded in the Office of the Essex County Clerk in Book 725 of Deeds at
15 Page 176, and RUNNING THENCE N 57° 07' 56" E, along said southerly
16 bounds, a distance of 296.17 feet, to a 1 inch iron pipe found in the
17 most westerly corner of a parcel of land belonging to Richard D. Railton
18 and Maries L Railton, by virtue of a deed recorded in the Office of the
19 Essex County Clerk in Book 810 of Deeds at Page 339;

20 THENCE TURNING and running S 48° 57' 21" E, along the southwesterly
21 bounds of Railton (L810-P339), passing through an iron rod at 99.94
22 feet, and passing through a 3/4 inch iron pipe at 200.24 feet, a total
23 distance of 614.50 feet, to the most northerly corner of a parcel of
24 land belonging to Richard D. Railton and Maries L Railton, by virtue of
25 a deed recorded in the Office of the Essex County Clerk in Book 993 of
26 Deeds at Page 346;

27 THENCE TURNING and running S 61° 14' 53" W, along the northwesterly
28 line of Railton (LP.), a distance of 255.24 feet, to the most westerly
29 corner thereof, being a 1/2 inch iron pipe set in the northeasterly
30 bounds of the aforementioned premises of (N/F) Betty Jane Smart
31 (L725-P176);

32 THENCE TURNING and running N 53° 11' 24" W, along the northeasterly
33 bounds of lands (N/F) of SMART (L725-P176), a distance of 700.31 feet,
34 to the point or place of beginning.

35 Parcel C

36 All that certain plot, piece or parcel of land, situate, lying and
37 being in the Town of Wilmington, County of Essex, State of New York,
38 briefly described as follows vis:

39 Commencing at the intersection of the southeast limit of Highway #86
40 with the southwest bank of White Brook; thence southwesterly along the
41 highway limit, 309.39 feet to a cedar stake which is the point of begin-
42 ning and which is also the northwest corner of Parcel #1 as shown on a
43 survey of Wilmington Development Company property by Norman Briggs, LS.,
44 dated July 1, 1952; thence S 50° 00' W, along the highway limit, 309.39
45 feet to a cedar stake; thence S 34' 00' 50" E. 1209.50 feet to a 4" x 4"
46 cedar post on the bank of the AuSable River; thence northeasterly
47 approximately 210 feet; following the river bank, to a 4" x 4" cedar
48 post which is also the southwest corner of Parcel #1; thence N. 49° 29'
49 50" W, 1180.73 feet to the point of beginning.

50 EXCEPTING FROM THE ABOVE DESCRIBED PARCEL:

51 All that tract or parcel of land situate in the Town of Wilmington,
52 County of Essex, State of New York, being part of Lot 33, Mallory's
53 Grant lying east of New York State Route 86 and west of the West Branch
54 of the AuSable River and is more particularly bounded and described as
55 follows:

1 Beginning at a point at the most northerly corner of the premises
2 marked by a 5/8 inch iron rod with cap, said point being the following
3 two (2) courses from a 3/4 inch iron pipe in the southeast bounds of New
4 York State Route 86 which lies 304.52 feet southwest of White Brook:

5 1. South 49° 25' 55" East, 395.00 feet;

6 2. South 49° 27' 22" East, 349.45 feet;

7 Thence, South 49° 27' 22" East, 450.00 feet along the southwest line

14 point at the southerly corner:

16 2. South 32° 53' 59" East, 40.69 feet to a point;

17 3. South 55° 14' 56" West, 65.59 feet to a point;

18 Thence, North 48° 23' 02" West, 246.21 feet along the southwesterly
19 line to 5/8 inch iron rod with cap, said course passing through a 5/8
20 inch iron rod line marker at a distance of 51.00 feet;

21 Thence, North 56° 25' 45" West, 95, 11 feet along the southwesterly
22 line to 5/8 inch iron rod with cap;

23 Thence, North 09° 51' 36" West, 179.07 feet along the west line to the
24 Point-of-Beginning.

25 Together with a right of way for all normal purposes of ingress and
26 egress over the existing drive from the southwest line of the premises
27 southwest and northwest to the New York State Route 86 and also the
28 right to maintain, repair and replace the existing utility lines provid-
29 ing service to the premises hereinabove described in their present
30 locations.

31 Parcel D

43 THENCE CONTINUING along said southwesterly line, S 48° 57' 21" passing
44 through a 1/2 inch iron pipe at 595.91 feet, a total distance of 629
45 feet more or less, to a point on the northerly bank of the AuSable
46 River, and to the most easterly corner of the 3.0 acre parcel herein
47 being described;

48 THENCE TURNING and running southwesterly and upstream, along the bank
49 of the AuSable River, a distance of 230 feet, more or less, to the most
50 easterly corner of a parcel of land belonging (N/F) to Florence
51 Williams; by virtue of a deed recorded in the Office of the Essex County
52 Clerk in Book 456 of Deeds at Page 19;

53 THENCE TURNING and running N 53° 11' 24" W, (passing through a 3/4
54 inch iron pipe at 20 feet, more or less), along the northeasterly line
55 of WILLIAMS (L456-P19), a distance of 415 feet, more or less, to the
56 most easterly corner of a parcel of land belonging (N/F) to Betty Jane

1 Smart, by virtue of a deed recorded In the Office of the Essex County
2 Clerk in Book 725 of Deeds at Page 176;

3 RUNNING THENCE N 53° 11' 24" W, along the northeasterly line of SMART
4 (L725-P176), (passing through a 3/4 inch iron rod at 99.47 feet), a
5 distance of 189.6 feet, to a 1/2 inch iron pipe, and to the most wester-
6 ly corner of the 3.0 acre parcel herein being described:

7 THENCE TURNING and running N 61° 14' 53" E, through lands belonging to
8 the High Valley Motel Corporation, by virtue of a deed recorded in the
9 Office of the Essex County Clerk in Book 940 of Deeds at Page 142, a
10 distance of 255.24 feet, to the point or place of beginning.

11 Parcel E

12 All that tract or parcel of land situate in the Town of Wilmington,
13 County of Essex, State of New York, being part of Lot 33, Mallory's
14 Grant lying east of New York State Route 86 and west of the West Branch
15 of the AuSable River and is more particularly bounded and described as

17 Beginning at a point at the most northerly corner of the premises
18 marked by a 5/8 inch iron rod with cap, said point being the following
19 two (2) courses from a 3/4 inch iron pipe in the southeast bounds of New
20 York State Route 86 which lies 304.52 feet southwest of White Brook:

21 1. South 49° 25' 55" East, 395.00 feet:

22 2. South 49° 27' 22" East, 349.45 feet;

23 Thence, South 49° 27' 22" East, 450.00 feet along the southwest line
24 of certain lands of Richard M. Sibalski and Jane F. Sibalski, Deed Book
25 772/Page 4, to a point on the west bank of the West Branch of the AuSa-
26 ble River, said course passing through a 1/2 inch iron pipe line marker
27 at a distance of 440.00 feet;

28 Thence, Southerly 130 feet more or less along the west bank of the
29 West Branch of the AuSable River on the following three (3) courses to a
30 point at the southerly corner:

31 1. South 29° 37' 1 0" Well, 32.66 feet to a point;

32 2. South 32° 53' 59" East, 40.69 feet to a point;

33 3. South 55° 14' 56" West, 65.59 feet to a point;

34 Thence, North 48° 23' 02" West, 246.21 feet along the southwesterly
35 line to a 5/8 inch iron rod with cap, said course passing through a 5/8
36 inch iron rod line marker at a distance of 51.00 feet;

37 Thence, North 56° 28' 45" West, 95.11 feet along the southwesterly
38 line to a 5/8 inch iron rod with cap;

39 Thence, North 09° 51' 36" West, 179.07 feet along the west line to the
40 Point-of Beginning. Together with a right of way for all normal purposes
41 of ingress and egress over the existing drive from the southwest line of
42 the premises southwest and northwest to New York State Route 86.

43 Parcel F

44 ALL THAT TRACT OR PARCEL OF LAND situate in the Town of Grand Island,
45 County of Erie and State of New York, being part of Lot No. 66, on said
46 Island, bounded and described as follows:

47 COMMENCING at the northeast comer of Lot No. 66; thence westerly along
48 the northerly line of Lot No. 66, 848.85 feet to its intersection with
49 the northeasterly line of the New York State Thruway; thence southeast-
50 erly along the northeasterly line of said Thruway 440.26 feet; thence
51 northerly in a straight line 767 feet to the place of beginning.

52 Parcel G

53 ALL THAT TRACT OR PARCEL OF LAND situate in the Town of Grand Island,
54 County of Erie and State of New York, being parts of Lots Nos. 82 and
55 83, on said Island, bounded and described as follows:

1 Beginning at the point of the intersection of the southwesterly line
 2 of Grand Island Connecting Boulevard and the easterly line of lands

 32 N 18° 21' 30" E, 461.0 feet to a 1" pipe;
 33 N 18° 21' 30" E, 829.7 feet to a 1" pipe, which marks the general
 34 northwest corner of said Davis parcel;

35 Running thence in the same course, N 18° 21' 30" E, and in an exten-
 36 sion northerly of the westerly boundary line of said Davis parcel
 37 so-called, a distance of 213 feet, more or less, to a point in the
 38 southerly boundary line of said premises reputedly owned by Mabel DeMa-
 39 si;

40 Running thence N 60° 57' W, and along the general southerly boundary
 41 line of said DeMasi property, so-called, a distance of 475 feet, more or

21 (xxiii) Part A

22 ALL that certain plot, piece or parcel of land, situate, lying and
23 being in the Borough of Manhattan, City, County and State of New York,
24 bounded and described as follows:

25 BEGINNING at a point on the easterly side of Thompson Street, distant 87
26 feet 5 inches southerly from the corner formed by the intersection of
27 the easterly side of Thompson Street with the southerly side of Spring
28 Street;

29 RUNNING THENCE Easterly on a line forming an interior angle of 89
30 degrees 47 minutes 30 seconds with the easterly side of Thompson Street
31 a distance of 87 feet 11 1/2 inches to a point in a line drawn northerly
32 along the westerly face of the westerly wall of the one story brick
33 building located on the premises adjoining on the east;

34 THENCE Southerly along the said line and along the westerly face of said
35 wall to the northerly face of another one story brick building on said
36 adjoining premises;

37 THENCE Westerly along the said northerly face of the said northerly wall
38 6 inches to the westerly face of the westerly wall of said building;

39 THENCE Southerly along the westerly face of said wall and a line in
40 continuation thereof to a line drawn at right angles to Thompson Street
41 from a point in the easterly side thereof distant 50 feet southerly from
42 the point of beginning.

43 THENCE Westerly at right angle to Thompson Street, 87 feet 6 1/2 inches
44 more or less to the easterly side of Thompson Street;

45 THENCE Northerly along the easterly side of Thompson Street, 50 feet to
46 the point or place of BEGINNING.

47 Part B

48 ALL that certain plot, piece or parcel of land, situate, lying and
49 being in the Borough of Manhattan, County of New York, City and State of
50 New York, bounded and described as follows:

51 BEGINNING at a point on the westerly side of West Broadway distant 93
52 feet 5 3/4 inches (U.S. Standard) southerly as measured along the
53 westerly side of West Broadway from the corner formed by the inter-
54 section of the southerly side of Spring Street with the westerly side of
55 West Broadway.

1 RUNNING THENCE in a general southerly direction along the westerly
2 side of West Broadway a distance of 47 feet 4 1/4 inches (U.S. Stand-
3 ard); RUNNING THENCE in a general westerly direction along a line form-
4 ing an interior angle of 89 degrees 54 minutes 25 seconds with the
5 westerly side of
6 West Broadway a distance of 75.0 feet (U.S. Standard);
7 RUNNING THENCE in a general northerly direction along a line forming an
8 interior angle of 90 degrees 05 minutes 35 seconds with the last
9 mentioned course a distance of 46 feet 11 5/8 inches (U.S. Standard);
10 RUNNING THENCE in a general easterly direction along a line forming an
11 interior angle of 90 degrees with the last mentioned course a distance
12 of 16.0 feet (U.S. Standard);
13 RUNNING THENCE in a general northerly direction along a line forming a
14 right angle with the last mentioned course a distance of 5 inches (U.S.
15 Standard); and
16 THENCE in a general easterly direction along a line forming an interior
17 angle of 89 degrees 51 minutes 30 seconds with the last mentioned course
18 a distance of 59.0 feet (U.S. Standard); to the westerly side of West
19 Broadway, the point or place of BEGINNING.

20 The above description is an overall description appearing of record in
21 Deed recorded 11/16/1988 in Reel 1494 Page 1438, which combines the
22 following PARCEL A and PARCEL B as described in said Deed and prior
23 Deeds of record:

24 PARCEL A (Being the northerly portion of TAX LOT 23):

25 All that certain plot, piece or parcel of land, situate, lying and being
26 in the Borough of Manhattan, City and State of New York, on the
27 northwesterly side of West Broadway, formerly Laurens Street, between
28 Spring and Broome Streets in the 8th Ward of the City of New York and
29 known on a Map of property belonging to Estate of Thomas Starr,
30 deceased, dated May 1827, made by Thomas R. Ludlam, C.S., conveyed to
31 said David Robbins by Deed Liber 238

32 Cp 454 which is bounded and described as follows;

33 BEGINNING at a point on the northwesterly side of said West Broadway
34 being the southerly corner of said Lot No. 85;

35 RUNNING THENCE northeasterly along the northwesterly side of West Broad-
36 way, 22 feet 4 inches more or less to the easterly corner of said brick
37 house; RUNNING THENCE northwesterly at right angles to said West Broad-
38 way and in part along said brick house; and

39 THENCE continuing in the same direction to the rear of the Lot, 100
40 feet;

41 THENCE, southeasterly along the rear of the Lot and parallel with West
42 Broadway, 22 feet 4 inches more or less to the westerly corner of said
43 Lot No. 85; and

44 RUNNING THENCE southwesterly at right angles to West Broadway, 100 feet
45 to said northwesterly side of West Broadway being the point or place of
46 BEGINNING.

47 Excepting so much as has been taken by the City of New York for the
48 widening of Laurens Street (formerly South 5th Avenue and now known as
49 West Broadway).

50 PARCEL B (Being the remaining portion of TAX LOT 23):

51 ALL that certain plot, piece or parcel of land, situate, lying and being
52 in the Borough of Manhattan, City, County and State of New York, bounded
53 and described as follows:

54 BEGINNING at a point on the westerly side of West Broadway, distant 115
55 feet 10 inches southerly from the corner formed by the intersection of
56 the westerly side of West Broadway with the southerly side of Spring

1 Street which point is at the northerly face of the northerly wall of the
2 building on the premises herein described;
3 RUNNING THENCE westerly along the northerly face of the northerly wall
4 of the building on the premises herein described and on a line in
5 continuation thereof nearly parallel with Spring Street, 75 feet;
6 THENCE southerly parallel with West Broadway 24 feet 10 inches to a
7 point in a line drawn in continuation of the southerly face of the
8 southerly wall of the building on the premises herein described;
9 THENCE easterly along said line and along the southerly face of the
10 southerly wall of the building on the premises herein described nearly
11 parallel with Spring Street, 75 feet to the westerly side of West Broad-
12 way; and THENCE, northerly along the westerly side of West Broadway, 25
13 feet to the point or place of BEGINNING.

14 Part C

15 ALL that lot, piece or parcel of land, situate, lying and being in the
16 Borough of Manhattan, City, County and State of New York, bounded and
17 described as follows:

18 BEGINNING at the corner formed by the intersection of the Northerly side
19 of 70th Street with the Westerly side of Madison Avenue;
20 THENCE Northerly along the Westerly side of Madison Avenue, 100 feet 5
21 inches to the center line of the block between 70th and 71st Streets;
22 THENCE Westerly parallel with the Northerly side of 70th Street and
23 along said center line of the block, 21 feet;
24 THENCE Southerly parallel with the Westerly side of Madison Avenue, 100
25 feet 5 inches to the Northerly side of 70th Street;
26 THENCE Easterly along the Northerly side of 70th Street, 21 feet to the
27 point or place of BEGINNING.

28 § 2. This act shall take effect immediately; provided, however, that
29 the amendments to subparagraph (xxii) of paragraph (a) of subdivision 13
30 of section 106 of the alcoholic beverage control law made by section one
31 of this act shall not affect the expiration of such subparagraph and
32 shall expire and be deemed repealed therewith; provided, however, that
33 upon the sale or transfer of the parcels detailed in subparagraph
34 (xxiii) of paragraph (a) of subdivision 13 of section 106 of the alco-
35 holic beverage control law as added by section one of this act, such
36 subparagraph shall expire and be deemed repealed unless the licensee
37 immediately obtains a leasehold upon such sale or transfer of such
38 parcel as part of the sale or transfer. If the licensee obtains such a
39 leasehold, the subparagraph pertaining to such parcel shall expire and
40 be deemed repealed upon the end or termination of such lease. The state
41 liquor authority shall notify the legislative bill drafting commission
42 upon notification by the licensee of the sale, transfer or termination
43 of the leasehold, or nonrenewal of the leasehold of the parcel detailed
44 in subparagraph (xix) of paragraph (a) of subdivision 13 of section 106
45 of the alcoholic beverage control law in order that the commission may
46 maintain an accurate and timely effective data base of the official text
47 of the laws of the state of New York in furtherance of effectuating the
48 provisions of section 44 of the legislative law and section 70-b of the
49 public officers law.
