Introduced by M. of A. ROZIC, COLTON -- read once and referred to the Committee on Election Law

AN ACT to amend the election law, in relation to designating additional participating agencies for purposes of agency assisted voter registration

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The opening paragraph of section 5-211 of the election law,  
2 as amended by section 7 of part PP of chapter 56 of the laws of 2022, is  
3 amended to read as follows:

4 Each agency designated as a participating agency under the provisions  
5 of this section shall implement and administer a program of distribution  
6 of voter registration forms pursuant to the provisions of this section.  
7 The following offices which provide public assistance and/or provide  
8 state funded programs primarily engaged in providing services to persons  
9 with disabilities are hereby designated as voter registration agencies:  
10 designated as the state agencies which provide public assistance are the  
11 office of children and family services, the office of temporary and  
12 disability assistance and the department of health. Also designated as  
13 public assistance agencies are all agencies of local government that  
14 provide such assistance. Designated as state agencies that provide  
15 programs primarily engaged in providing services to people with disabili-  
16 ties are the department of labor, office for the aging, department of  
17 veterans' services, office of mental health, office of vocational and  
18 educational services for individuals with disabilities, commission on  
19 quality of care for the mentally disabled, office for people with devel-  
20 opmental disabilities, commission for the blind, office of addiction  
21 services and supports, the office of the advocate for the disabled and  
22 all offices which administer programs established or funded by such  
23 agencies. Additional participating agencies designated as voter regis-  
24 tration offices are the department of state and the district offices of

1 the workers' compensation board. Such agencies shall be required to  
2 offer voter registration forms to persons upon initial application for  
3 services, renewal or recertification for services and upon change of  
4 address relating to such services. Such agencies shall also be responsi-  
5 ble for providing assistance to applicants in completing voter registra-  
6 tion forms, receiving and transmitting the completed application form  
7 from all applicants who wish to have such form transmitted to the appro-  
8 priate board of elections. The state board of elections shall, together  
9 with representatives of the United States department of defense, develop  
10 and implement procedures for including recruitment offices of the armed  
11 forces of the United States as voter registration offices when such  
12 offices are so designated by federal law. The state board of elections  
13 shall also make request of the United States Citizenship and Immigration  
14 Services to include applications for registration by mail with any mate-  
15 rials which are given to new citizens. Also designated as participating  
16 agencies are all public libraries, which shall be required to offer  
17 voter registration forms to persons eighteen years of age or older upon  
18 initial application for a library card. Also designated as participating  
19 agencies are all local housing authorities, which shall be required to  
20 offer voter registration forms to persons upon initial application for  
21 services or recertification for services. Also designated as participat-  
22 ing agencies are all public high schools, which shall be required to  
23 offer voter registration forms to all seniors upon their graduation.

24 § 2. This act shall take effect on the one hundred twentieth day after  
25 it shall have become a law; provided, however, that if part PP of chap-  
26 ter 56 of the laws of 2022 shall not have taken effect on or before such  
27 date then section one of this act shall take effect on the same date and  
28 in the same manner as such chapter of the laws of 2022 takes effect.  
29 Effective immediately, the addition, amendment and/or repeal of any rule  
30 or regulation necessary for the implementation of this act on its effec-  
31 tive date are authorized to be made and completed on or before such  
32 effective date.
