AN ACT to amend the election law, in relation to designating additional participating agencies for purposes of agency assisted voter registration

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The opening paragraph of section 5-211 of the election law, as amended by section 7 of part PP of chapter 56 of the laws of 2022, is amended to read as follows:

amended to read as follows: Each agency designated as a participating agency under the provisions of this section shall implement and administer a program of distribution of voter registration forms pursuant to the provisions of this section. The following offices which provide public assistance and/or provide state funded programs primarily engaged in providing services to persons with disabilities are hereby designated as voter registration agencies: 10 designated as the state agencies which provide public assistance are the 11 office of children and family services, the office of temporary and disability assistance and the department of health. Also designated as 13 public assistance agencies are all agencies of local government that 14 provide such assistance. Designated as state agencies that provide 15 programs primarily engaged in providing services to people with disabilities are the department of labor, office for the aging, department of 16 veterans' services, office of mental health, office of vocational and 17 educational services for individuals with disabilities, commission on 18 quality of care for the mentally disabled, office for people with devel-19 20 opmental disabilities, commission for the blind, office of addiction 21 services and supports, the office of the advocate for the disabled and 22 all offices which administer programs established or funded by such 23 agencies. Additional participating agencies designated as voter regis-24 tration offices are the department of state and the district offices of

the workers' compensation board. Such agencies shall be required to 2 offer voter registration forms to persons upon initial application for services, renewal or recertification for services and upon change of address relating to such services. Such agencies shall also be responsi-5 ble for providing assistance to applicants in completing voter registration forms, receiving and transmitting the completed application form 7 from all applicants who wish to have such form transmitted to the appropriate board of elections. The state board of elections shall, together 9 with representatives of the United States department of defense, develop 10 and implement procedures for including recruitment offices of the armed 11 forces of the United States as voter registration offices when such offices are so designated by federal law. The state board of elections 12 shall also make request of the United States Citizenship and Immigration 13 14 Services to include applications for registration by mail with any mate-15 rials which are given to new citizens. Also designated as participating agencies are all public libraries, which shall be required to offer 16 17 voter registration forms to persons eighteen years of age or older upon 18 initial application for a library card. Also designated as participating agencies are all local housing authorities, which shall be required to 19 offer voter registration forms to persons upon initial application for 20 21 services or recertification for services. Also designated as participat-22 ing agencies are all public high schools, which shall be required to 23 offer voter registration forms to all seniors upon their graduation. 24 § 2. This act shall take effect on the one hundred twentieth day after 25

it shall have become a law; provided, however, that if part PP of chapter 56 of the laws of 2022 shall not have taken effect on or before such date then section one of this act shall take effect on the same date and in the same manner as such chapter of the laws of 2022 takes effect. Effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its effective date are authorized to be made and completed on or before such 32 effective date.
