AN ACT to amend the vehicle and traffic law and the penal law, in relation to increasing fines and penalties for passing a stopped school bus

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision (c) of section 1174 of the vehicle and traffic 1 2 law, as amended by chapter 254 of the laws of 2002, is amended to read 3 as follows: 4 (c) Every person convicted of a violation of subdivision (a) of this section shall be subject to the following fines and penalties: 5 (i) for a first conviction thereof, be punished by a fine of not less б than [two hundred fifty] four hundred dollars nor more than [four 7 8 hundred] seven hundred fifty dollars or by imprisonment for not more 9 than thirty days or by both such fine and imprisonment; 10 (ii) for a conviction of a second violation, both of which were committed within a period of three years, such person shall be punished 11 12 by a fine of not less than [six hundred dollars] nine hundred fifty dollars nor more than [seven hundred fifty] one thousand one hundred 13 14 **fifty** dollars or by imprisonment for not more than one hundred eighty 15 days or by both such fine and imprisonment; (iii) upon a conviction of a third or subsequent violation, all of 16 17 which were committed within a period of three years, such person shall be punished by a fine of not less than [seven hundred fifty] one thou-18

19 <u>sand one hundred fifty</u> dollars nor more than [<u>one thousand</u>] <u>one thousand</u>] 20 <u>five hundred</u> dollars or by imprisonment for not more than one hundred 21 eighty days or by both such fine and imprisonment.

22 § 2. Subdivision 6 of section 120.04-a of the penal law, as added by 23 chapter 496 of the laws of 2009, is amended and a new subdivision 7 is 24 added to read as follows:

8	§ 125.10 Criminally negligent homicide.
9	A person is guilty of criminally negligent homicide when[, with] <u>:</u>
10	<u>1. With</u> criminal negligence, he <u>or she</u> causes the death of another
11	person[-]; or
12	2. He or she causes the death of another person or persons while oper-
13	ating a motor vehicle in violation of subdivision (a) of section eleven
14	hundred seventy-four of the vehicle and traffic law.
15	Criminally negligent homicide is a class E felony.
