AN ACT to amend the education law, in relation to establishing the COVID-19 children scholarship

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. The education law is amended by adding a new section 608-b
2	to read as follows:
3	§ 608-b. COVID-19 children scholarships. 1. Notwithstanding subdivi-
4	sion five of section six hundred sixty-one of this title, children whose
5	parent, primary caretaker or sibling died or was disabled as a result of
б	contracting COVID-19, shall be eligible to receive a scholarship in an
7	annual amount determined pursuant to subdivision two of section six
8	<u>hundred sixty-eight-h of this title.</u>
9	2. Awards under this section shall be payable for each of not more
10	than four academic years of undergraduate study or five academic years
11	if a program normally requires five years, as defined by the commission-
12	er pursuant to this article.
13	§ 2. The education law is amended by adding a new section 668-h to

the annual award shall be an amount equal to: the tuition charged at 1 such institution provided that, notwithstanding any provision of law to 2 3 the contrary, the tuition charged to award recipients shall not exceed 4 that charged to state resident students attending such institution; the 5 mandatory fees charged at such institution; and the non-tuition cost of 6 attendance at such institution or college, provided that the scholarship 7 shall not exceed an amount that is equal to the total cost of attendance 8 determined for federal Title IV student financial aid purposes, less all other scholarships and grants provided by New York state, other states, 9 10 the federal government, or other governments, and the amount of educa-11 tional benefits paid under any program that would duplicate the purposes 12 of this program, provided that any scholarships or grants provided to a recipient by the institution which are intended to fund any portion of 13 the difference between the annual state award and the actual costs of 14 15 attendance at any such institution shall not be considered to duplicate 16 the purposes of this program; or 17 (2) If the recipient attends any other two- or four-year institution within New York state, the annual award shall be based upon an amount 18 equal to: the tuition charged to state resident students attending a 19 20 four-year college of the state university of New York; the average 21 mandatory fees charged at four-year colleges of the state university of 22 New York, or the actual tuition and fees charged to the recipient, whichever is less; and the average non-tuition cost of attendance, as 23 determined by the president and as approved by the director of the budg-24 25 et, for a student at the state university of New York or actual non-tuition cost of attendance at such institution, whichever is less, provided 26 27 that the scholarship shall be at least two thousand five hundred dollars 28 per year, and provided that the scholarship shall not exceed an amount that is equal to the total cost of attendance determined for federal 29 30 Title IV student financial aid purposes, less all other scholarships and grants provided by New York state, other states, the federal government, 31 32 or other governments, and the amount of educational benefits paid under 33 any program that would duplicate the purposes of this program, provided 34 that any scholarships or grants provided to a recipient by the institu-35 tion which are intended to fund any portion of the difference between 36 the annual state award and the actual costs of attendance at any such 37 institution shall not be considered to duplicate the purposes of this 38 program. 39 (3) "Non-tuition cost of attendance", as used in this subdivision, shall mean: (i) the actual amount charged by the institution for room 40 and board, and (ii) an allowance for transportation, books and supplies 41 42 as determined by the president and as approved by the director of the 43 budget, provided that such determination shall be made no later than 44 December first of each year for use in the succeeding academic year. In 45 the event a student does not incur room or board charges at the institu-46 tion, "non-tuition cost of attendance" shall mean an allowance for room 47 and board as determined by the president and approved by the director of 48 the budget. In determining allowances pursuant to this subparagraph, the 49 president may take into consideration the allowances provided for in the 50 <u>Pell grant program.</u> 51 (b) In no event shall the combination of all student financial aid 52 received by a student exceed a recipient's total cost of attendance at the institution being attended. 53 54 3. Duration. Awards under this section shall be payable for each of not more than four academic years of undergraduate study or five academ-55
