AN ACT to amend the vehicle and traffic law, in relation to discontinuing service fees for distinctive license plates issued to veterans

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 3 of section 404-h of the vehicle and traffic 1 law, as amended by chapter 415 of the laws of 2001, is amended to read 2 3 as follows: 4 3. A distinctive plate issued pursuant to this section shall be issued 5 in the same manner as other number plates upon payment of the regular registration fee prescribed by section four hundred one of this article б 7 [provided, however, that an additional one-time service charge of ten 8 dollars shall be charged for such plate]. 9 § 2. Subdivision 4 of section 404-j of the vehicle and traffic law, as 10 amended by chapter 415 of the laws of 2001, is amended to read as 11 follows: 12 4. Fee. A special plate and registration issued pursuant to this 13 section shall be issued upon payment of the regular registration fee 14 prescribed by section four hundred one of this article [provided, howev-15 er, that an additional one-time service charge of ten dollars shall be 16 charged for such plate]. 17 § 3. Subdivision 3 of section 404-k of the vehicle and traffic law, as amended by chapter 415 of the laws of 2001, is amended to read as 18 follows: 19 20 3. A distinctive plate issued pursuant to this section shall be issued 21 in the same manner as other number plates upon payment of the regular 22 registration fee prescribed by section four hundred one of this article 23 [provided, however, that an additional one-time service charge of ten 24 dollars shall be charged for such plate].

The commissioner may issue special number plates to applicants 30 who are members of veterans organizations in the same manner as other 31 number plates are issued pursuant to this article. Such special number 32 plates shall be issued only upon (a) payment of a one-time service 33 charge of ten dollars in addition to the regular registration fee 34 prescribed by section four hundred one of this article, provided that
