Introduced by M. of A. L. ROSENTHAL, WILLIAMS, PAULIN, LAVINE, COLTON, SIMON, GLICK -- read once and referred to the Committee on Agriculture

AN ACT to amend the agriculture and markets law, in relation to the prohibition of certain acts in rodeos

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- Section 1. The agriculture and markets law is amended by adding a new section 352 to read as follows:
  - § 352. Use of animals in rodeos. 1. For the purposes of this section:
- 4 (a) "Calf roping" shall mean capturing a calf with a lasso and binding tis feet or allowing it to run free.
- 6 (b) "Electric prod" shall mean a handheld device used to make cattle
  7 or other livestock move by striking or poking such animal with such
  8 device which shocks such animal with a high voltage, low current elec9 tric shock.
- 10 (c) "Flank strap" or "bucking strap" shall mean a strap or rope which 11 is tightly cinched around the abdomen of a horse or bull causing such 12 animal to buck.
- 13 (d) "Person" shall mean any individual, partnership, limited liability
  14 company, corporation, joint venture, association, trust, estate or any
  15 other legal entity, and any officer, member, shareholder, director,
- 16 employee, agent or representative of any such entity.
- 17 <u>(e) "Rodeo" shall mean a public exhibition in which skills such as</u>
  18 <u>riding bulls or broncos, or roping animals, are displayed.</u>
- 19 <u>(f) "Spur with a fixed or sharpened rowel" shall mean a sharp prod</u>
  20 <u>fixed to the heel of the rider of an animal which is used to enhance or</u>
  21 <u>increase the intensity of the bucking of the animal.</u>
- 22 2. No person in a rodeo shall:
- 23 (a) engage in calf roping;
- 24 (b) use flank straps or bucking straps on horses, bulls, cattle, or
- 25 <u>other livestock;</u>

(c) use electric prods on horses, bulls, cattle, or other livestock; 1 2 **or** 

- (d) use spurs with fixed or sharpened rowels on horses, bulls, cattle, 4 <u>or other livestock.</u>
  - 3. (a) Any person that violates the provisions of this section, or any rule or regulation promulgated pursuant thereto, may be assessed, by the commissioner, a civil penalty of not more than ten thousand dollars for each such violation. Each violation and each day during which a violation continues shall constitute a separate violation.
- 10 (b) Any person that violates the provisions of this section, shall 11 have any permit or license to operate as a rodeo revoked.
- 12 4. Any venue that hosts a rodeo that violates the provisions of this section, or any rule or regulation promulgated pursuant thereto, shall 13 14 lose its eligibility for any state tax abatements.
- 15 § 2. This act shall take effect on the thirtieth day after it shall 16 have become a law.
