AN ACT to amend the banking law and the real property law, in relation to credit line mortgages

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 380-g of the banking law, as added by chapter 625 of the laws of 1976, is amended to read as follows:

§ 380-g. Power to engage in line of credit financing of residential real estate. 1. A savings and loan association is authorized to invest an amount, not exceeding the lesser of (a) ten per centum of the sum of its surplus, undivided profits, and reserves or (b) one per centum of its assets, in loans or in interests therein the principal purpose of which is to provide financing with respect to what is or is expected to 9 become primarily residential real estate within this state, where (i) 10 the association relies substantially for repayment on the borrower's 11 general credit standing, with or without other security, or (ii) the association relies on other assurances for repayment, including but not limited to a guaranty or similar obligation of a third party, and, in 14 either case described in clause (i) or (ii), regardless of whether or 15 not the association takes security.

A savings and loan association shall not revoke, or otherwise 17 block, a borrower's access to credit financing of residential real 18 estate authorized pursuant to subdivision one of this section if such 19 borrower is current on repayment related to such credit financing of 20 <u>residential real estate.</u>
