AN ACT to amend the general business law, in relation to requiring telemarketers to provide certain information no later than thirty seconds from the commencement of a call and requiring telemarketers to disclose their address online and in written communication to customers

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The opening paragraph of subdivision 2 of section 399-z of 2 the general business law, as amended by chapter 660 of the laws of 2022, is amended to read as follows:

No telemarketer or seller shall engage in telemarketing at any time 5 other than between 8:00 A.M. and 9:00 P.M. at the location of the customer unless the customer has given [his or her] their express consent to the call at a different time. Telemarketers shall provide, in a clear and coherent manner using words with common and everyday meanings, at the beginning but no later than thirty seconds from the 10 commencement of the call of each telemarketing sales call all of the 11 following information, provided that the information set forth in para-12 graphs a and b of this subdivision shall be given to the customer first: § 2.
